2 Protection of Black Bears.

3 **§ 19A-10. Unlawful to buy, sell or enclose (except as provided) black bear.**

4 Except as otherwise provided in applicable statutes, it shall be unlawful for any person to
5 buy or sell black bears or for any person, firm or corporation to possess or keep any black bear
6 (Ursus americanus) in any enclosure, pen, cage, or other place or means of captivity except as
7 hereinafter provided. (1975, c. 56, s. 1.)

9 **§ 19A-11. Inapplicable to bona fide zoos, etc.**

10 The provisions of this Article shall not apply to bona fide zoos which are operated by
11 federal, State, or local governmental agencies, or to educational institutions in which black
12 bears are kept or exhibited as part of a bona fide course of training or research in the natural
13 sciences, or to black bears held without caging under conditions simulating a natural habitat,
14 the development of which is in accord with plans and specifications developed by the holder
15 and approved by the Wildlife Resources Commission. (1975, c. 56, s. 2.)

17 **§ 19A-12. Possession of black bear on July 1, 1975; surrender of bear; modification of**
18 **facilities; forfeiture.**

19 Any person, firm or corporation in possession of a black bear on July 1, 1975, under an
20 existing permit issued by the Wildlife Resources Commission, where the conditions under
21 which such black bear is held are in violation of this Article, may immediately surrender such
22 black bear and such permit to the Wildlife Resources Commission which shall compensate
23 such person, firm or corporation in the amount actually paid for such bear not to exceed the
24 sum of one hundred dollars (\$100.00) for any one bear. In lieu of surrendering such black bear
25 and such permit, any such person, firm or corporation may give immediately written notice to
26 the Wildlife Resources Commission that plans and specifications for facilities to hold such bear
27 without caging under conditions simulating a natural habitat will be submitted to the
28 Commission for approval within 30 days thereafter. In the event such plans and specifications
29 are not submitted within the time thus limited, or they are disapproved by the Commission, or
30 the facilities are not completed in accordance therewith within 60 days after approval by the
31 Commission, continued possession of a black bear by such person, firm or corporation after any
32 of such events shall constitute a violation of the provisions of this Article, and any such black
33 bear shall be forfeited to the Wildlife Resources Commission without compensation. (1975, c.

36 **§ 19A-13. Violation of Article.**

37 Violation of the provisions of this Article shall constitute a Class 2 misdemeanor. (1975, c.
38 56, s. 4; 1993, c. 539, s. 314; 1994, Ex. Sess., c. 24, s. 14(c).)

40 **§ 19A-14. Enforcement of Article.**

41 Law-enforcement officers of the Wildlife Resources Commission and all other peace
42 officers are authorized and empowered to enforce the provisions of this Article. (1975, c. 56, s.
43 5.)
