#### A BILL TO BE ENTITLED

#### 2 AN ACT TO PROVIDE FOR WAIVER OF CERTAIN CERTIFICATION TRAINING 3 TUITION AND FEES FOR EMPLOYEES OF THE DIVISION OF YOUTH

- 4 SERVICES, DEPARTMENT OF HUMAN RESOURCES.
- 5 The General Assembly of North Carolina enacts: 6

Section 1. G.S. 115D-5(b) reads as rewritten:

In order to make instruction as accessible as possible to all citizens, the 7 "(b) teaching of curricular courses and of noncurricular extension courses at convenient 8 locations away from institution campuses as well as on campuses is authorized and shall 9 be encouraged. A pro rata portion of the established regular tuition rate charged a full-10 time student shall be charged a part-time student taking any curriculum course. In lieu 11 of any tuition charge, the State Board of Community Colleges shall establish a uniform 12 registration fee, or a schedule of uniform registration fees, to be charged students 13 enrolling in extension courses for which instruction is financed primarily from State 14 funds; provided, however, that the State Board of Community Colleges may provide by 15 general and uniform regulations for waiver of tuition and registration fees for persons 16 not enrolled in elementary or secondary schools taking courses leading to a high school 17 diploma or equivalent certificate, for training courses for volunteer firemen, local fire 18 department personnel, volunteer rescue and lifesaving department personnel, local 19 rescue and lifesaving department personnel, local law-enforcement officers, patients in 20 State alcoholic rehabilitation centers, all full-time custodial employees of the 21 Department of Correction and-Correction, employees of the Department's Division of 22 Adult Probation and Parole required to be certified pursuant to Chapter 17C of the 23

General Statutes and the rules of the Criminal Justice and Training Standards 1 Commission, Commission and employees of the Department of Human Resources' 2 3 Division of Youth Services trainees enrolled in courses conducted under the New and Expanding Industry Program, clients of sheltered workshops, clients of adult 4 developmental activity programs, students in Human Resources Development 5 6 Programs, juveniles of any age committed to the Division of Youth Services of the Department of Human Resources by a court of competent jurisdiction, and prison 7 inmates. Provided further, tuition shall be waived for senior citizens attending 8 9 institutions operating pursuant to this Chapter as set forth in Chapter 115B of the 10 General Statutes, Tuition Waiver for Senior Citizens."

11 Sec. 2. This act shall become effective July 1, 1989, and applies to tuition 12 and fees due on and after that date.
