AN ACT TO AUTHORIZE THE DEPARTMENT OF F

AN ACT TO AUTHORIZE THE DEPARTMENT OF ENVIRONMENT, HEALTH, AND NATURAL RESOURCES TO ESTABLISH AND IMPLEMENT A PROGRAM TO ASSIST LOW-INCOME INDIVIDUALS TO OBTAIN PRESCRIPTION DRUGS AT REDUCED COST.

The General Assembly of North Carolina enacts:

Section 1. (a) Short title. This act shall be known as the Prescription Drug Assistance Act.

(b) Purpose. The General Assembly recognizes that many of North Carolina's low-income citizens are unable to afford the cost of prescription drugs for treatment of certain life-threatening illnesses. The General Assembly further recognizes that cooperative efforts between State and local government agencies and the private sector are often successful in providing important services to local communities, which services would not otherwise be available because of limited government resources. The purpose of this act is to authorize the Department of Environment, Health, and Natural Resources to facilitate local public and private sector cooperative efforts to identify and assist low-income individuals in obtaining certain prescription drugs at reduced cost.

Sec. 2. Prescription Drug Assistance Program. (a) There is established in the Department of Environment, Health, and Natural Resources, Division of Adult Health, a Prescription Drug Assistance Program. The purpose of the program is to assist local communities in identifying and securing the commitment of private sector resources or services and the cooperation of State and local agencies that provide health and social services, to enable eligible individuals to purchase prescription drugs for the treatment

of arthritis, diabetes, epilepsy, and cardiovascular disease at reduced cost. The cost for prescription drugs covered by the Prescription Drug Assistance Program shall be established by the Commission for Health Services, provided that such cost shall not exceed the maximum charges for prescription drugs reimbursable under the Medicaid Program.

- (b) In administering the Prescription Drug Assistance Program the Department of Environment, Health, and Natural Resources, Division of Adult Health, shall:
 - (1) Identify and study issues relating to the medication needs of low-income persons throughout the State;
 - (2) Promote and coordinate voluntary efforts to assist eligible individuals in obtaining prescription drugs available under the Program at reduced cost to the individual or, if resources are available, at no cost to the individual;
 - (3) Provide materials or other outreach efforts that inform potentially eligible persons of the Program's existence and how they may obtain additional information about the Program;
 - (4) Collect, analyze, and report data to assist the Commission for Health Services in evaluating the implementation and effectiveness of the Prescription Drug Assistance Program.

In addition to the responsibilities described above, the Department may:

- (1) Solicit funds, goods, or services to be designated and administered for the benefit of individuals eligible for assistance under the Program;
- (2) Engage in any other activities or efforts determined by the Commission for Health Services to be necessary and appropriate to implement this act.
- (c) Pursuant to its responsibilities under this act, and subject to funds available, the Department of Environment, Health, and Natural Resources, Division of Adult Health, may provide medications, services, or other related benefits directly to individuals eligible for Program services. Further pursuant to its responsibilities under this act, the Department may enter into informal agreements or written contracts with public or private entities for the purposes of obtaining or providing prescription drugs available under the Program for eligible individuals; provided, however, that any agreement or contract that contains a financial commitment or otherwise imposes a financial obligation on the State shall be in writing and shall not be binding upon the State unless the agreement or contract has the written approval of the Secretary of Environment, Health, and Natural Resources.
- (d) Eligibility. Assistance in obtaining prescription drugs at reduced cost under the Prescription Drug Assistance Program shall be granted to any person who:
 - (1) Has insufficient income to pay for prescribed medication of the kind available under the Prescription Drug Assistance Program; provided that no person whose income exceeds two hundred

- percent (200%) of the poverty level shall be eligible for assistance under the Program; and

 Is not receiving assistance that pays the cost of prescribed
 - (2) Is not receiving assistance that pays the cost of prescribed medication of the kind covered by the Prescription Drug Assistance Program, under the program of medical assistance established under G.S. 108A-54.
 - (e) Assistance received by an individual under the Prescription Drug Assistance Program shall not be considered in determining the amount of assistance to be paid to the individual under Chapters 108A and 111 of the General Statutes, except where such assistance is required to be considered by federal law or regulations.
 - (f) An application processing fee not to exceed five dollars (\$5.00) per initial application and each renewal thereafter may be collected from each individual applying for assistance under the Prescription Drug Assistance Program. Individuals deemed eligible for assistance shall be issued a card identifying the individual as eligible for assistance. Identification cards shall be valid for a period not exceeding two years and may be renewed upon application by the individual and determination that the individual is eligible for assistance.
 - Sec. 3. The Commission for Health Services shall adopt rules necessary to implement this act.
 - Sec. 4. There is appropriated from the General Fund to the Department of Environment, Health, and Natural Resources the sum of \$200,000 for the 1990-91 fiscal year to be used for administrative costs to implement the Prescription Drug Assistance Act.
 - Sec. 5. Sections 1 and 3 of this act are effective upon ratification. Section 4 of this act shall become effective July 1, 1990. Section 2 of this act shall become effective October 1, 1990.
