A BILL TO BE ENTITLED

2 AN ACT TO AMEND THE MEMBERSHIP REQUIREMENTS FOR THE BOARD

3 OF GOVERNORS OF THE NORTH CAROLINA MOTOR VEHICLE

- 4 REINSURANCE FACILITY.
- 5 The General Assembly of North Carolina enacts:
 - Section 1. G.S. 58-248.33(d) reads as rewritten:

"(d) The Facility shall be administered by a Board of Governors. The Board of 7 Governors shall consist of nine-12 members having one vote each from the 8 classifications hereinafter enumerated plus the Commissioner who shall serve ex officio 9 without vote. Each Facility insurance company member serving on the Board shall be 10 represented by a senior officer of the company. Not more than one company in a group 11 under the same ownership or management shall be represented on the Board at the same 12 time. Five members of the Board shall be selected by the member insurers, which 13 members shall be fairly representative of the industry. To insure representative member 14 insurers, one each shall be selected from the following groups: the American Insurance 15 Association (or its successors), the American Mutual Insurance Alliance Alliance of 16 American Insurers (or its successors), the National Association of Independent Insurers 17 18 (or its successors), all other stock insurers not affiliated with the above groups, and all 19 other nonstock insurers not affiliated with the above groups. The Commissioner shall appoint two members of the Board who shall be Facility insurance company members 20 domiciled in this State. The Commissioner shall appoint one member of the Board who 21 shall be selected from a list of two nominees submitted by the Auto Insurance Agents of 22 North Carolina, Inc. The Commissioner of Insurance shall appoint four members of the 23 Board who shall be fire and casualty insurance agents licensed in this State and actively 24

engaged in writing motor vehicle insurance in this State. The Commissioner shall select 1 2 one agent from among a list of two nominees submitted by the Independent Insurance 3 Agents of North Carolina, Inc., and one agent from among a list of two nominees submitted by the Carolinas Association of Professional Insurance Agents. The initial 4 5 term of office of said Board members shall be two years. Following completion of 6 initial terms, successors to the members of the original Board of Governors shall be 7 selected to serve three years. All members of the Board of Governors shall serve until 8 their successors are selected and qualified and the Commissioner may fill any vacancy 9 on the Board from any of the aforementioned classifications until such vacancies are 10 filled in accordance with the provisions of this Article. The Board of Governors of the Facility shall also have as nonvoting members two persons who are not employed by or 11 12 affiliated with any insurance company or the Department of Insurance and who are 13 appointed by the Governor to serve at his pleasure."

14 Sec. 2. This act is effective upon ratification.
