A BILL TO BE ENTITLED

- AN ACT TO SIMPLIFY THE REQUIREMENTS FOR ELECTION DAY VOTER 2 3 TRANSFERS. 4 The General Assembly of North Carolina enacts:
- 5
 - Section 1. G.S. 163-72.3 reads as rewritten:

"§ 163-72.3. Change of address on election day; authorization to vote. 6

A registered voter who has moved from one precinct to another within the 7 (a) same county more than 30 days before a primary or election, but who has not submitted 8 a change of address report as provided in G.S. 163-72.2, nevertheless may vote under 9 the following procedure: 10

- 11 (1)On the day of the primary or election the voter must go to the polling place for the precinct at which the voter is registered. If the precinct at 12 which the voter is registered is not open for that election, the voter 13 shall go instead to the county board of elections office or to another 14 location designated by the board, at which place a board employee or 15 election official designated by the board shall issue the certificate of 16 removal and perform the other duties specified below for the precinct 17 officials. 18
- 19 Upon determining that the voter is registered in that precinct but (2)20 moved more than 30 days before, the precinct registrar, precinct 21 assistant appointed under G.S. 163-42, or a judge shall issue to the voter a certificate of removal on the following form: 22

17	(3)	Upon issuance of the certificate to the voter, the precinct official shall
18		mark the voter's registration record with a 'T' in the appropriate voting
19		square to indicate that the voter has transferred.
20	(4)	The voter shall take the certificate of removal to the precinct transfer
21		assistant at the county board of elections' office. Upon determining
22		that the voter moved more than 30 days before the election, that the
23		voter now resides in another precinct within the county, and that the
24		voter is otherwise qualified to vote in the election, the precinct transfer
25		assistant shall have the voter complete the proper precinct transfer
26		forms. The precinct transfer assistant shall then provide the voter with
27		the proper ballots, or access to the proper voting equipment, for the
28		precinct where the voter now resides. If the voter fails to take the
29		certificate of removal to the precinct transfer assistant at the county
30		board of elections' office by the time the polls close on election day,
31		the voter may at a later date submit a change of address report under $C \leq 1/2$ 72.2 to become affective as maxidad by law.
32	(5)	G.S. 163-72.2 to become effective as provided by law.
33	(5)	After marking the ballots, or using the voting equipment in a booth or
34 35		separate room provided for that purpose voting, the voter shall place the ballots, if any, in an envelope provided by the precinct transfer assistant.
35 36		That envelope shall have printed or stamped on it the following:
37		Transfer voter ballot #
38		Assigned precinct
39		The precinct transfer assistant shall write the proper information in
40		the blanks before giving the envelope to the voterin the proper ballot
41		box.
42	(6)	The precinct transfer assistant shall enter in a book provided by the
43		board of elections the name of each voter permitted to vote under this
44		section, the number assigned to the voter's ballot and envelope, the precinct

3 4	(7)	Envelopes containing ballots voted under this section shall be retained to be opened and the ballots counted after the polls close on election

5 6		day. Ballots voted at the board office shall be counted <u>after the polls</u> <u>have closed</u> by board members or assistants appointed by the board.
7		Ballots voted at other locations shall be counted by the precinct
8		transfer assistants assigned to those locations, aided by precinct
9		officials or ballot counters for those locations, provided that if the
10		other location is the polling place at which the person would have
11		voted if a change of address report had been filed under G.S. 163-72.2
12		prior to the close of registration for the election, the ballots shall be
13		counted in the same manner as those of other voters. At each location
14		all envelopes shall be opened and all ballots deposited in the
15		appropriate boxes before any ballots are counted, and other than the
16		polling place at which the person would have voted if a change of
17		address report had been filed under G.S. 163-72.2 prior to the close of
18		registration for the election, the results of the counting shall be entered
19		on duplicate transfer report forms signed by the officials responsible
20		for the counting.
21		If the county board of elections designates a precinct voting place
22		as a location for voting under this section, and only voters who now
23		reside in that precinct are permitted to vote transfer ballots there, the
24		board may direct the precinct officials to place the transfer ballots in
25		the appropriate precinct ballot boxes immediately after the polls close
26		and to count and report the results of the transfer ballots together with
27	(0)	all other ballots voted in the precinct.
28	(8)	A person voting under this section shall be entitled to the same
29	(0)	assistance as provided in G.S. 163-152.
30	(9)	The precinct officials and precinct transfer assistant may require a
31		person to show identification if needed to establish that the person is

39 The board may appoint precinct transfer assistants in addition to those (c) authorized by subsection (b) and assign them to locations other than the board of 40 41 elections' office, provided the board adopts a resolution approving such additional appointments and gives written notice to the State Board of Elections of the additional locations 42 at least 60 days before the election. The board may provide that each polling place open 43 for an election shall be an additional location, and that each voter shall, after receiving a 44

certificate under subdivision (2) of subsection (a), go to vote at the polling place where 1 2 they would have been assigned if they had filed a change of address report under G.S. 3 163-72.2 prior to the time that registration closed for the election. If such provision is made, the registrar, judge, or precinct assistant issuing a certificate under subdivision 4 5 (2) of subsection (a) shall notify the voter of the location of such polling place. If 6 additional locations are established, the county board may make the appropriate changes 7 in the forms and procedures to be used under subsection (a). To exercise any option 8 permitted to it in this subsection, the county board of elections shall adopt a resolution 9 and give written notice to the State Board of Elections at least 60 days before the 10 election. The notice shall include the additional locations at which transfer voting will be allowed. 11 12 (d)Each precinct transfer assistant shall be paid at least thirty-five dollars 13 (\$35.00) for the duties performed on election day, and may be paid additional 14 compensation as recommended by the board of elections and authorized by the board of 15 county commissioners."

16 Sec. 2. This act shall become effective with respect to primaries and 17 elections held on or after September 1, 1989. This act shall expire on January 1, 1991, 18 and not be effective with respect to primaries and elections on or after that date.
