HOUSE BILL 613

Short Title: Water Pollution Control Permits.

A BILL TO BE ENTITLED

AN ACT TO REGULATE MINOR ACTIVITIES THROUGH GENERAL PERMIT APPROVAL OR THROUGH CONDITIONS IN RULES, AND TO ELIMINATE UNNECESSARY MONITORING AND REPORTING FOR CERTAIN PERMITS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 143-215.1(b) reads as rewritten:

"(b) Commission's Power as to Permits. – The Commission shall act on all permits so as to prevent, so far as reasonably possible, considering relevant standards under State and federal laws, any significant increase in pollution of the waters of the State from any new or enlarged sources.

The Commission shall have the power:

(1) To grant a permit with such conditions attached as the Commission believes necessary to achieve the purposes of this Article;

(1a) To require that an applicant satisfy the Commission that the applicant, or any parent or subsidiary corporation if the applicant is a corporation:

a. Is financially qualified to carry out the activity for which the permit is required under subsection (a); and

b. Has substantially complied with the effluent standards and limitations and waste management treatment practices applicable to any activity in which the applicant has previously engaged, and has been in substantial compliance with other federal and state laws, regulations, and rules for the protection of the environment;

- 1 (3) To modify or revoke any permit upon not less than 60 days' written
2 notice to any person affected.
- 3 (4) To designate certain classes of minor activities for which a general
4 permit may be issued, after considering:
5 a. The environmental impact of the activities;
6 b. How often the activities are carried out;
7 c. The need for individual permit oversight; and
8 d. The need for public review and comment on individual permits.
9 General permits may be issued using the rule-making procedures of
10 Chapter 150B of the General Statutes. Thereafter, appropriate
11 individual activities may be covered under the general permit
12 according to the conditions outlined in the adopted rules. All
13 individuals covered under general permits shall be subject to the same
14 enforcement remedies as those individuals covered under individual
15 permits.
- 16 (5) To designate certain classes of minor activities for which:
17 a. Performance conditions may be established by rule; and
18 b. Individual or general permits are not required.
- 19 (6) To adopt rules which exempt the filter backwash facilities of
20 swimming pools and spas from:
21 a. The application and notice requirements of this section; and
22 b. The reporting requirements of G.S. 143-215.65 and the
23 monitoring requirements of G.S. 143-215.66.

24 No permit shall be denied and no condition shall be attached to the permit, except
25 when the Commission finds such denial or such conditions necessary to effectuate the
26 purposes of this Article."

27 Sec. 2. G.S. 143-215.65 reads as rewritten:

28 "**§ 143-215.65. Reports required.**

29 All persons subject to the provisions of G.S. 143-215.1 who discharge wastes to the
30 waters or emit air contaminants to the outdoor atmosphere of this State shall file at such
31 frequencies as the Commission may specify ~~and at least quarterly~~ reports with the
32 Commission setting forth the volume and characteristics of wastes discharged or air
33 contaminants emitted daily or such other period of time as may be specified by the
34 Commission in its rules. Such reports shall be filed on forms provided by the
35 Department and approved by the Commission and shall include such pertinent data with
36 reference to the total and average volume of wastes or air contaminants discharged, the
37 strength and amount of each waste substance or air contaminant discharged, the type
38 and degree of treatment such wastes or air contaminants received prior to discharge and
39 such other information as may be specified by the Commission in its rules. The
40 information shall be used by the Commission only for the purpose of air and water
41 pollution control. The Department shall provide proper and adequate facilities and
42 procedures and the Commission shall adopt rules to safeguard the confidentiality of
43 proprietary manufacturing processes except that confidentiality shall not extend to
44 wastes discharged or air contaminants emitted."

1 Sec. 3. This act is effective upon ratification.
