1 A BILL TO BE ENTITLED
2 AN ACT TO PROVIDE FEES TO BE CHARGED BY THE SECRETARY OF STATE
3 UNDER THE REVISED BUSINESS CORPORATION ACT.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 55-1-22 reads as rewritten:

6 "§ 55-1-22. Reserved for future codification purposes. Filing, service, and copying fees.

7 (a) The Secretary of State shall collect the following fees when the documents
8 described in this subsection are delivered to him for filing:

Table with 2 columns: Document and Fee. Rows include: (1) Articles of incorporation \$100.00, (2) Application for reserved name 10.00, (3) Notice of transfer of reserved name 10.00, (4) Application for registered name 10.00, (5) Application for renewal of registered name 10.00, (6) Corporation's statement of change of registered agent or registered office or both 5.00, (7) Agent's statement of change of registered office for each affected corporation 5.00, (8) Agent's statement of resignation No fee, (9) Designation of registered agent or registered office or both 5.00, (10) Amendment of articles of incorporation 50.00, (11) Restated articles of incorporation with amendment of articles 10.00, (12) Articles of merger or share exchange 50.00.

14 (23) Annual report 5.00
15 (24) Articles of correction 10.00
16 (25) Application for certificate of existence or authorization 5.00
17 (26) Any other document required or permitted to be filed by this act 10.00.
18 (b) The Secretary of State shall collect a fee of ten dollars (\$10.00) each time
19 process is served on him under this act. The party to a proceeding causing service of
20 process is entitled to recover this fee as costs if he prevails in the proceeding.
21 (c) The Secretary of State shall collect the following fees for copying and
22 certifying the copy of any filed document relating to a domestic or foreign corporation:
23 (1) Fifty cents (\$.50) a page for copying; and
24 (2) Five dollars (\$5.00) for the certificate."
25 Sec. 2. This act shall become effective July 1, 1990, and shall not become
26 effective unless Senate Bill 280 of the 1989 General Assembly is ratified.
