A BILL TO BE ENTITLED
AN ACT TO PROVIDE FEES TO BE CHARGED BY THE SECRETARY OF STATE
UNDER THE REVISED BUSINESS CORPORATION ACT.

The General Assembly of North Carolina enacts:

Section 1. G.S. 55-1-22, as enacted by Chapter 265 of the 1989 Session
Laws, reads as rewritten:

"§ 55-1-22. ~~Reserved for future codification purposes.~~ Filing, service, and copying fees.

(a) The Secretary of State shall collect the following fees when the documents
described in this subsection are delivered to him for filing:

20 (b) The Secretary of State shall collect a fee of ten dollars (\$10.00) each time
21 process is served on him under this act. The party to a proceeding causing service of
22 process is entitled to recover this fee as costs if he prevails in the proceeding.
23 (c) The Secretary of State shall collect the following fees for copying and
24 certifying the copy of any filed document relating to a domestic or foreign corporation:
25 (1) Fifty cents (\$.50) a page for copying; and
26 (2) Five dollars (\$5.00) for the certificate."
27 Sec. 2. This act shall become effective July 1, 1990.
