## AN ACT TO ALLOW ALAMANCE COUNTY TO OPERATE A COUNTY FARM TO HOUSE NONVIOLENT MISDEMEANANTS.

The General Assembly of North Carolina enacts:
Section 1. The County of Alamance may operate the property described in Section 2 of this act to house nonviolent misdemeanants without being subject to the provisions of G.S. 153A-220, 153A-221.1, 153A-222, and 153A-230.5. The Board of Commissioners of Alamance County shall adopt minimum standards for the operation of the facility prior to its use.

Sec. 2. The authorization in Section 1 of this act applies only to the property described below:
"All of that certain tract or parcel of land in Patterson Township, Alamance County, North Carolina, adjoining the lands of Dace Moon, William Kimball, York Teague, A.C. Isley, and others and bounded and described as follows:

BEGINNING at a stone a corner with Freedom Hill Church Tract and Dace Moon; running thence with the line of said Moon and William Kimball, N. $37^{\circ} 30^{\prime}$ W. 1397.7 ft . to a large tree and rocks, to corner with said Kimball and Teague land; running thence with the line of said Teague due West 1782 ft . to corner with said Teague and A.C. Isley at the center of a road; running thence with the center of dirt road and with the line of said Isley and York Teague, S. $10^{\circ} 30^{\prime}$ E. 1833.10 ft . to a point in the center of said road and to corner with said York Teague; running thence with the line of said York Teague S. $87^{\circ}$ E. 475 ft . to corner with York Teague; thence again with his line S . $19^{\circ} \mathrm{E} .400 \mathrm{ft}$. to a stake in the line of said York Teague; thence again with his line S. $27^{\prime}$ E. 795.8 ft . to a rock in the line of said York Teague; thence again with his line $\mathrm{S} .3^{\circ} \mathrm{W}$.
1650.5 ft . to a stone, corner with said York Teague and (unknown land,) running thence 2 at a right angle, with the line of the unknown land, S. $87^{\circ}$ E. 1437 ft . to a stake in the 3 line of Mr. Whitehead; running thence with the line of said Whitehead N. $7^{\circ}$ E. 462 ft . 4 to an ash tree and pointers at a corner with said Whitehead; thence $\mathrm{N} .84^{\circ} \mathrm{W} .313 .6 \mathrm{ft}$. 5 to a large post oak and pointers; running thence N. $6^{\circ} 55^{\prime} \mathrm{E} .2000 \mathrm{ft}$. to the 6 BEGINNING, containing 138.31 acres more or less."

Sec. 3. This act is effective upon ratification.
