| 9 | (a) If any tax imposed by this Subchapter, or any other tax levied by the State |

Except as otherwise provided in this subdivision, the levy upon the 11 12 sale of personal property shall be governed by the laws regulating levy and sale under execution. The person to whom the warrant is directed 13 14 shall proceed to levy upon and sell the personal property subject to 15 levy in the same manner and with the same powers and authority normally exercised by sheriffs in levying upon and selling personal 16 17 property under execution, except that the property may be sold in Wake County or in the county in which it was seized, in the discretion 18 of the Secretary. In addition to the notice of sale required by the laws 19 20 governing sale of property levied upon under execution, the Secretary 21 may advertise the sale in any reasonable manner and for any reasonable period of time to produce an adequate bid for the property. 22 23 Levy and sale fees, plus actual advertising costs, shall be added to and 24 collected in the same manner as taxes." 25
