A BILL TO BE ENTITLED

AN ACT TO CONSOLIDATE AND SIMPLIFY THE SPECIAL LICENSE PLATE LAWS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 20-80 through G.S. 20-81.2 and G.S. 20-81.4 through G.S. 20-81.11 are repealed.

Sec. 2. Chapter 20 of the General Statutes is amended by adding the following new sections to Part 5 of Article 3 of that Chapter to read:

**"§ 20-79.4. Special registration plates.**

(a) Types. – Upon application and payment of the required registration fees, a person may obtain from the Division a special registration plate for a motor vehicle registered in that person's name if the person qualifies for the registration plate. The Division shall issue the following types of special registration plates:

(1) Administrative Officer of the Courts. – Issuable to the Director of the Administrative Office of the Courts. The plate shall bear the phrase 'J-20'.

(2) Amateur Radio Operator. – Issuable to an amateur radio operator licensed by the Federal Communications Commission. The plate shall bear the operator's official amateur radio call letters.

(3) Civil Air Patrol Member. – Issuable to an active member of the North Carolina Wing of the Civil Air Patrol. The plate shall bear the phrase 'Civil Air Patrol'. A plate issued to an officer member shall begin with

1           the number '201' and the number shall reflect the seniority of the  
2           member; a plate issued to an enlisted member, a senior member, or a  
3           cadet member shall begin with the number '501'.

4           (4) Class D Citizen's Radio Station Operator. – Issuable to a Class D  
5           citizen's radio station operator licensed by the Federal  
6           Communications Commission. The plate shall bear the operator's  
7           official Class D citizen's radio station call letters.

8           (5) Clerk of Superior Court. – Issuable to a clerk of superior court. The  
9           plate shall bear the phrase 'Clerk Superior Court' and the letter 'C'  
10           followed by a number that indicates the county the clerk serves.

11           (6) Coast Guard Auxiliary Member. – Issuable to an active member of the  
12           United States Coast Guard Auxiliary. The plate shall bear the phrase  
13           'Coast Guard Auxiliary'.

14           (7) Congressional Medal of Honor Recipient. – Issuable to a recipient of  
15           the Congressional Medal of Honor.

16           (8) Disabled Veteran. – Issuable to a veteran of the armed forces of the  
17           United States who suffered a 100% service-connected disability.

18           (9) District Attorney. – Issuable to a North Carolina or United States  
19           District Attorney. The plate issuable to a North Carolina district  
20           attorney shall bear the letters 'DA' followed by a number that  
21           represents the prosecutorial district the district attorney serves. The  
22           plate for a United States attorney shall bear the phrase 'U.S. Attorney'  
23           followed by a number that represents the district the attorney serves,  
24           with 1 being the Eastern District, 2 being the Middle District, and 3  
25           being the Western District.

26           (10) Fire Department or Rescue Squad Member. – Issuable to an active  
27           regular member or volunteer member of a fire department, rescue  
28           squad, or both a fire department and rescue squad. The plate shall bear  
29           the words 'Firefighter', 'Rescue Squad', or 'Firefighter-Rescue Squad'.

30           (11) Historic Vehicle Owner. – Issuable for a motor vehicle that is at least  
31           35 years old measured from the date of manufacture. The plate for a  
32           vehicle that is 35 to 50 years old shall bear the phrase 'Antique'. The  
33           plate for a vehicle that is at least 50 years old shall bear the phrase  
34           'Horseless Carriage'.

35           (12) Judge or Justice. – Issuable to a sitting or retired judge or justice in  
36           accordance with G.S. 20-79.6.

37           (13) Legislator. – Issuable to a member of the North Carolina General  
38           Assembly. The plate shall bear the words 'Senate' or 'State House'  
39           followed by the Senator's or Representative's assigned seat number.

40           (14) Marshal. – Issuable to a United States Marshal. The plate shall bear  
41           the phrase 'U.S. Marshal' followed by a number that represents the  
42           district the Marshal serves, with 1 being the Eastern District, 2 being  
43           the Middle District, and 3 being the Western District.

- 1           (15) Military Reservist. – Issuable to a member of a reserve component of  
2 the armed forces of the United States. The plate shall bear the name  
3 and insignia of the appropriate reserve component. Plates shall be  
4 numbered sequentially for members of a component with the numbers  
5 1 through 5000 reserved for officers, without regard to rank.
- 6           (16) National Guard Member. – Issuable to an active or a retired member of  
7 the North Carolina National Guard. The plate shall bear the phrase  
8 'National Guard'. A plate issued to an active member shall bear a  
9 number that reflects the seniority of the member; a plate issued to a  
10 commissioned officer shall begin with the number '1'; a plate issued to  
11 a noncommissioned officer with a rank of E7, E8, or E9 shall begin  
12 with the number '1601'; a plate issued to an enlisted member with a  
13 rank of E6 or below shall begin with the number '3001'. The plate  
14 issued to a retired or separated member shall indicate the member's  
15 retired status.
- 16           (17) Partially Disabled Veteran. – Issuable to a veteran of the armed forces  
17 of the United States who suffered a service connected disability of less  
18 than 100%.
- 19           (18) Pearl Harbor Survivor. – Issuable to a veteran of the armed forces of  
20 the United States who was present at and survived the attack on Pearl  
21 Harbor on December 7, 1941. The plate will bear the phrase 'Pearl  
22 Harbor Survivor' and the insignia of the Pearl Harbor Survivors'  
23 Association.
- 24           (19) Personalized. – Issuable to the registered owner of a motor vehicle.  
25 The plate will bear the letters or letters and numbers requested by the  
26 owner. The Division may refuse to issue a plate with a letter  
27 combination that is offensive to good taste and decency. The Division  
28 may not issue a plate that duplicates another plate.
- 29           (20) Prisoner of War. – Issuable to a member or veteran member of the  
30 armed forces of the United States who has been captured and held  
31 prisoner by forces hostile to the United States while serving in the  
32 armed forces.
- 33           (21) Purple Heart Recipient – Issuable to a recipient of the Purple Heart  
34 award. The plate shall bear the phrase 'Purple Heart Veteran, Combat  
35 Wounded' and the letters 'PH'.
- 36           (22) State Government Official. – Issuable to elected and appointed  
37 members of State government in accordance with G.S. 20-79.5.
- 38           (23) Street Rod Owner. – Issuable to the registered owner of a modernized  
39 private passenger motor vehicle manufactured prior to the year 1949 or  
40 designed to resemble a vehicle manufactured prior to the year 1949.  
41 The plate shall bear the phrase 'Street Rod'.
- 42           (24) Transportation Personnel. – Issuable to various members of the  
43 Divisions of the Department of Transportation. The plate shall bear

the letters 'DOT' followed by a number from 1 to 85, as designated by the Governor.

(25) U.S. Representative. – Issuable to a United States Representative for North Carolina. The plate shall bear the phrase 'U.S. House' and shall be issued on the basis of Congressional districts represented by the numbers 1 through 11.

(26) U.S. Senator. – Issuable to a United States Senator for North Carolina. The plates shall bear the phrase 'U.S. Senate' and shall be issued on the basis of seniority represented by the numbers 1 and 2.

(b) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. The annual fee for a special plate issuable to an active member of the national guard is the amount of the regular motor vehicle registration fee. The annual fee for a personalized plate issued under this section is the amount of the regular motor vehicle registration fee plus an additional twenty dollars (\$20.00). The annual fee for any other special plate listed in this section is the regular motor vehicle registration fee plus an additional ten dollars (\$10.00).

The Division shall credit the revenue derived from the additional fee collected for any special plate to the Special Registration Plate Fund.

(c) Disqualification. – A holder of a special license plate who becomes ineligible for the plate, for whatever reason, shall return the special plate within 30 days.

**§ 20-79.5. Special registration plates for elected and appointed State government officials.**

(a) Plates. – The State government officials listed in this section are eligible for a special registration plate under G.S. 20-79.4. The plate shall bear the number designated in the following table for the position held by the official.

38 (b) Designation. – When the table in subsection (a) designates a range of  
 39 numbers for certain officials, the number given an official in that group shall be  
 40 assigned. The Governor shall assign a number for members of the Governor's staff,  
 41 nonlegislative members of the Advisory Budget Commission, nonlegislative members  
 42 of the Board of Economic Development, nonlegislative members of the State Ports  
 43 Authority, members of State boards and commissions, and for State employees. The

1 Attorney General shall assign a number for the Attorney General's deputies and  
2 assistants.

3 The first number assigned to the Alcoholic Beverage Control Commission is  
4 reserved for the Chair of that Commission. The remaining numbers shall be assigned to  
5 the Alcoholic Beverage Control Commission members on the basis of seniority. The  
6 first number assigned to the Utilities Commission is reserved for the Chair of that  
7 Commission. The remaining numbers shall be assigned to the Utilities Commission  
8 members on the basis of seniority. The first number assigned to the Parole Commission  
9 is reserved for the Chair of that Commission. The remaining numbers shall be assigned  
10 to the Parole Commission members on the basis of seniority.

11 **"§ 20-79.6. Special registration plates for members of the judiciary.**

12 (a) Appellate Division. – A special plate issued to a Justice or Judge of the North  
13 Carolina Appellate Courts shall bear the letter 'J' followed by a number from 1 through  
14 19. The Chief Justice of the Supreme Court of North Carolina shall be issued the plate  
15 bearing the number 1 and the remaining plates shall be issued to the Associate Justices  
16 on the basis of seniority. The Chief Judge of the North Carolina Court of Appeals shall  
17 be issued the next judicial plate and the remaining plates shall be issued to the Associate  
18 Judges on the basis of seniority. Special plates issued to retired members of the  
19 Supreme Court and the Court of Appeals shall bear a number indicating the member's  
20 position of seniority at the time of retirement followed by the letter 'X' to indicate the  
21 member's retired status.

22 (b) Superior Court. – A special plate issued to a resident superior court judge  
23 shall bear the letter 'J' followed by a number indicative of the judicial district the judge  
24 serves. The number issued to the senior resident superior court judge shall be equal to  
25 the sum of the numerical designation of the judge's judicial district, as defined in G.S.  
26 7A-41.1(a)(1), plus 20. If a district has more than one regular resident superior court  
27 judge, a special plate for a resident superior court judge of that district shall bear the  
28 number issued to the senior resident superior court judge followed by a hyphen and a  
29 letter of the alphabet beginning with the letter 'A' to indicate the judge's seniority.

30 For a set of districts as defined in G.S. 7A-41.1(a)(2), other than 7A and 7C, the  
31 number issued to the senior resident superior court judge shall be equal to the sum of 20  
32 plus the number the districts in the set have in common. A special plate issued to the  
33 other regular resident superior court judges of the set of districts shall bear the number  
34 issued to the senior resident superior court judge followed by a hyphen and a letter of  
35 the alphabet beginning with the letter 'A' to indicate the judge's seniority among all of  
36 the regular resident superior court judges of the set of districts. The letter assigned to a  
37 resident superior court judge will not necessarily correspond with the letter designation  
38 of the district the judge serves. For the set of districts 7B and 7C, the senior resident  
39 superior court judge for that set shall be issued a special plate bearing the designation  
40 7C following the letter 'J', and all other resident superior court judges of the set shall be  
41 issued a special plate bearing that designation followed by the letter 'B'.

42 A special judge, emergency judge, or retired judge of the superior court shall be  
43 issued a special plate bearing the letter 'J' followed by a number designated by the  
44 Administrative Office of the Courts with the approval of the Chief Justice of the

1 Supreme Court of North Carolina. The plate for a retired judge shall have 'X' after the  
2 designated number to indicate the judge's retired status.

3 (c) District Court. – A special plate issued to a North Carolina district court  
4 judge shall bear the letter 'J' followed by a number. For the chief judge of the district  
5 court district, the number shall be equal to the sum of the numerical designation of the  
6 district court district the chief judge serves, plus 100. The number for all other judges  
7 of the district courts serving within the same district court district shall be the same  
8 number as appears on the special plate issued to the chief district judge followed by a  
9 letter of the alphabet beginning with the letter 'A' to indicate the judge's seniority. A  
10 retired district court judge shall be issued a similar plate except that the numerical  
11 designation shall be followed by the letter 'X' to indicate the judge's retired status.

12 (d) United States. – A special plate issued to a Justice of the United States  
13 Supreme Court, a Judge of the United States Circuit Court of Appeals, or a District  
14 Judge of the United States District Court residing in North Carolina shall bear the words  
15 'U.S. J' followed by a number beginning with '1'. The number shall reflect the judge's  
16 seniority based on continuous service as a United States Judge as designated by the  
17 Secretary of State. A judge who has retired or taken senior status shall be issued a  
18 similar plate except that the number shall be based on the date of the judge's retirement  
19 or assumption of senior status and shall follow the numerical designation of active  
20 justices and judges."

21 Sec. 3. G.S. 20-81.3 is recodified as G.S. 20-79.7 and reads as rewritten:

22 "**§ 20iRegistration Plate Fund.**

23 (a) ~~The Commissioner may promulgate rules on the issuance of special~~  
24 ~~personalized registration plates to the owner of private passenger motor vehicles, private~~  
25 ~~trucks, or commercial motor vehicles weighing 5,000 pounds or more gross weight, in~~  
26 ~~lieu of other number plates. Such personalized registration plate shall be of such design~~  
27 ~~and shall bear such letter or letters and numerals as the Commissioner shall prescribe,~~  
28 ~~but there shall be no duplication of a registration plate. The Commissioner shall in his~~  
29 ~~discretion refuse the issue of such letter combinations which might carry connotations~~  
30 ~~offensive to good taste and decency. – Fund. – The Special Registration Plate Fund is~~  
31 ~~established. The Fund consists of the revenue derived from the additional fee collected~~  
32 ~~for any special registration plate issued under G.S. 20-79.4. The Commissioner shall~~  
33 ~~deduct the costs of the special registration plates, including the costs of issuing,~~  
34 ~~handling, and advertising the availability of the special plates, from the Fund.~~

35 (b) ~~An owner who desires personalized registration plates shall make application~~  
36 ~~for such plates on forms which shall be provided by the Division of Motor Vehicles and~~  
37 ~~pay the sum of twenty dollars (\$20.00) annually, which shall be in addition to the~~  
38 ~~regular motor vehicle registration fee. Once an owner has obtained personalized plates,~~  
39 ~~he, where possible, will have first priority on those plates for the following years~~  
40 ~~provided he makes timely and appropriate application; provided, however, that the~~  
41 ~~Commissioner shall not issue a personalized license plate pursuant to this section except~~  
42 ~~upon written application therefor on a form furnished by the Commissioner in which the~~  
43 ~~applicant certifies that his operator's or chauffeur's license has not been revoked or~~  
44 ~~suspended under Article 2 of Chapter 20 of the General Statutes within two years prior~~

1 to the date of the application; and provided, further, that any personalized license plate  
2 issued pursuant to this section shall be cancelled and recalled by the Commissioner and  
3 the application fee forfeited in the event that the Commissioner determines that a false  
4 application has been submitted. Initial Distribution of Proceeds. – After deducting the  
5 costs of the special registration plates from the Fund, one-half of the proceeds in the  
6 Fund shall be transferred quarterly to the Recreation and Natural Heritage Trust Fund  
7 established under G.S. 113-77.7. From the remaining one-half of the proceeds, the  
8 Secretary of Transportation may allocate and reserve up to one hundred thousand  
9 dollars (\$100,000) to the Department of Transportation each fiscal year for the purpose  
10 of traffic control at major events as provided for by G.S. 136-44.2. Any funds allocated  
11 for traffic control that are neither used nor obligated at the end of the fiscal year shall  
12 remain in the Fund and be used in accordance with subsection (c) of this section.

13 (c) ~~One half of the revenue derived from the additional fee shall be deposited in~~  
14 ~~the Recreation and Natural Heritage Trust Fund established under G.S. 113-77.7. The~~  
15 ~~remaining one half of the revenue derived from the additional fee for the special~~  
16 ~~personalized registration plates shall be placed in a separate fund designated the~~  
17 ~~"Personalized Registration Plate Fund". After deducting the cost of the plates, plus~~  
18 ~~budgetary requirements for advertising, handling, and issuance to be determined by the~~  
19 ~~Commissioner, the revenue in the Personalized Registration Plate~~ Use of Remaining  
20 Proceeds. – The remaining revenue in the Fund shall be transferred quarterly as follows:

- 21 (1) Thirty-three percent (33%) to the account of the Department of  
22 Economic and Community Development to aid in financing out-of-  
23 state print and other media advertising under the program for the  
24 promotion of travel and industrial development in this State.
- 25 (2) Fifty percent (50%) to the Department of Transportation to be used  
26 solely for the purpose of beautification of highways other than those  
27 designated as interstate. These funds shall be administered by the  
28 Department of Transportation for beautification purposes not  
29 inconsistent with good landscaping and engineering principles.
- 30 (3) Seventeen percent (17%) to the account of the Department of Human  
31 Resources to promote travel accessibility for disabled persons in this  
32 State. These funds shall be ~~used~~ used to collect and update site  
33 information on travel attractions designated by the Department of  
34 Economic and Community Development in its ~~publications;~~  
35 publications, to provide technical assistance to travel attractions

41            "**§ 168-2. Right of access to and use of public places.**

42            Handicapped persons have the same right as the ablebodied to the full and free use  
 43            of the streets, highways, sidewalks, walkways, public buildings, public facilities, and all  
 44            other buildings and facilities, both publicly and privately owned, which serve the public.

1 The Department of Human Resources shall develop, print, and promote the publication
