4	ESTABLISH A NEW CATEGORY OF MEMBERS EMERITUS OF THE BOARD
5	OF GOVERNORS OF THE UNIVERSITY OF NORTH CAROLINA.
6	The General Assembly of North Carolina enacts:
7	Section 1. Chapter 116 of the General Statutes is amended by adding a new
8	section to read:
9	" <u>§ 116-6.1. Student member of the Board of Governors.</u>
10	(a) <u>Commencing July 1, 1991, and during his continuance as a student in good</u>
11	standing at a constituent institution of The University of North Carolina, the person
12	serving as president of the University of North Carolina Association of Student
13	Governments (UNCASG) or his designee shall serve ex officio as a member of the
14	Board of Governors. This student member shall be in addition to the 32 members
15	elected to the Board of Governors.
16	(b) The student member shall have all the rights and privileges of membership,
17	except that he shall not have a vote."
18	Sec. 2. G.S. 116-6(f) is amended as follows:
19	"(f). Any person who has served at least one full term as chairman of the Board of
20	Governors shall be a member emeritus of the Board of Governors for one four-year term

beginning at the expiration of that member's regular elected term. Any person already 1 2 serving as an emeritus member may serve an additional four-year term beginning July 1, 3 1991. Members emeriti have all the rights and privileges of membership except they do not have a vote." 4 5 Sec. 3. G.S. 116-6 is amended by adding a new subsection to read: 6 "(g) Effective July 1, 1991, and thereafter, any person who has served at least one 7 term as a member of the Board of Governors after having served as Governor of North 8 Carolina shall be a member emeritus of the Board of Governors, with all the rights and 9 privileges of membership as in G.S. 116-6(f)." Sec. 4. Section 2 of this act shall be implemented within funds available for 10 the operations of the Board of Governors of The University of North Carolina. Nothing 11 12 in Section 2 of this act shall be construed to obligate the General Assembly to 13 appropriate additional funds for the operating costs of the Board of Governors.

14 Sec. 5. This act is effective upon ratification.
