A BILL TO BE ENTITLED

1 AN ACT TO MAKE APPOINTMENTS TO PUBLIC OFFICE UPON THE  
2 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE  
3 AND TO CORRECT AN APPOINTMENT.

5 Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
6 appointments to public office upon the recommendation of the President Pro Tempore  
7 of the Senate; and

8 Whereas, the President Pro Tempore of the Senate has made such  
9 recommendations; Now, therefore,

10 The General Assembly of North Carolina enacts:

11 Section 1. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to the Genetic  
12 Engineering Review Board for a term to expire on June 30, 1995.

13 Sec. 2. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to the North  
14 Carolina Manufactured Housing Board for a term beginning October 1, 1992, and  
15 expiring September 30, 1995. This is the categorical appointment for a manufactured  
16 home supplier.

17 Sec. 3. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to the North  
18 Carolina Manufactured Housing Board for a term beginning October 1, 1992, and  
19 expiring September 30, 1995. This is the categorical appointment for a set-up  
20 contractor.

21 Sec. 4. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to the North  
22 Carolina Hazardous Waste Management Commission for a term expiring June 30, 1994.

1           Sec. 5. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to the North  
2 Carolina Center for Nursing Board of Directors for a term expiring June 30, 1994. This  
3 is the categorical appointment for a representative of the hospital industry.

4           Sec. 6. Section 8 of Chapter 759, Session Laws of 1991, reads as rewritten:

5           "Sec. 8. Henry Faircloth of Sampson County is appointed to the Real Estate  
6 Appraisal Board for a term to expire on June 30, ~~1994~~1993."

7           Sec. 7. Senator \_\_\_\_\_ of \_\_\_\_\_ County and Senator  
8 \_\_\_\_\_ of \_\_\_\_\_ County are appointed to the North Carolina Travel and  
9 Tourism Board for terms beginning on January 1, 1993, and expiring on December 31,  
10 1994. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to the North Carolina Travel  
11 and Tourism Board for a term beginning on January 1, 1993, and expiring on December  
12 31, 1994. This is the categorical appointment for a person associated with the tourism-  
13 related transportation industry. \_\_\_\_\_ of \_\_\_\_\_ County is appointed to  
14 the North Carolina Travel and Tourism Board for a term beginning on January 1, 1993,  
15 and expiring on December 31, 1994. This is the categorical appointment for a public  
16 member interested in matters relating to travel and tourism.

17           Sec. 8. Except as otherwise provided, appointments made by this act are for  
18 terms commencing July 1, 1992.

19           Sec. 9. This act is effective upon ratification.
