Amends G.S. 1113A-103(5)(a) to clarify that BILL SUMMARY: "placement" of a structure is subject to CAMA permitting requirements. Amends G.S. 113A-124(c) to grant the Coastal Resources Comm'n authority to delegate decisions regarding granting requests for contested case hearings and declaratory rulings. Amends G.S. 113A-126 regarding injunctive relief to require the court to, at a minimum, issue orders to prevent or abate the violation in accordance with the terms of CAMA (1) limit definition of "placement and CRC rules. House amendments: of structure" (as contained in definition of "development") to such activity in estuarine waters and public trust areas; and (2) replace requirement of restoration to an undisturbed condition with restoration consistent with the requirements of CAMA and Coastal Resources Comm'n rules. Further amended 6/18 House amendment adds definitions of "boat" and "floating structure" to GS 113A-103.
