BILL SUMMARY: The bill authorizes the Division of Motor Vehicles to issue permanent registration plates for commercial trailers and semi-trailers upon application of the vehicle owner. Currently, the annual registration fee for these trailers is \$10. The fee for a permanent commercial trailer plate would be \$75. Permanent plates would not be transferable.

ASSUMPTIONS AND METHODOLOGY:

Currently there are 310,000 commercial trailers registered in NC. If 10% apply for a permanent plate in January 1993, there would be a one-time gain to the Highway Fund in next year's budget of \$2.1 million. Each year thereafter for the life of the trailer, there would be an annual \$310,000 loss to the Highway Fund from a loss of the \$10 annual fee. Long-term revenue neutrality depends upon the average life of a commercial trailer. If seven years, the long-term revenue effect is neutral. If ten years or longer, the Highway Fund would lose \$775,000. The trucking industry claims the availability of a permanent plate will be an incentive for more companies to base their trailers in North Carolina. That result may occur, but the revenue impact is not quantifiable and has not been factored into this estimate. SOURCES OF DATA: Division of Motor Vehicles
