A BILL TO BE ENTITLED

AN ACT TO CLARIFY WHO SHALL BE ENTITLED TO THE PRIVILEGES AND ADVANTAGES OF THE PUBLIC SCHOOLS, WHO SHALL PAY TUITION, AND TO CREATE AN EDUCATION POWER OF ATTORNEY.

The General Assembly of North Carolina enacts:

Section 1. G.S. 115C-364 reads as rewritten:

"§ 115C-364. Admission requirements.

A child, to be entitled to initial entry in the public schools, must have passed the fifth anniversary of his/her birth. A child is entitled to initial entry in the public schools if the child is five years old on or before October 16 of the year in which the child is presented for enrollment, and must be is presented for enrollment during the first month of the school year. The initial point of entry into the public school system shall be at the kindergarten level: Provided, that if a particular child has already been attending school in another state in accordance with the laws or regulations of the school authorities of such state before moving to and becoming a resident of North Carolina, such that state, the child will be is eligible for enrollment in the schools of this State in accordance with this Article regardless of whether such child has passed the fifth anniversary of his birth his or her fifth birthday before October 16. If the principal of a school finds as fact subsequent to initial entry that a child, by reason of maturity can be more appropriately served in the first grade rather than in kindergarten, the principal may act under the provisions of G.S. 115C-288 to implement this educational decision without regard to chronological age. The principal of any public school shall have the authority to require the parents of any child presented for admission for the first time to such school to furnish a certified copy of the child's birth certificate of such child, which shall be furnished by the register of

1 ~~deeds of the county having on file the record of the birth of such child, or other satisfactory~~
2 ~~evidence of date of birth."~~

3 Sec. 2. G.S. 115C-366 is repealed.

4 Sec. 3. G.S. 115C-366.2 is repealed.

5 Sec. 4. Article 25 of Chapter 115C is amended by adding a new section to
6 read:

7 **"§ 115C-364.1. Eligibility to attend public schools; school assignment.**

8 (a) All persons under the age of 21 years who are domiciled in a school
9 administrative unit and who have neither been removed from school for cause, nor
10 obtained a high school diploma, shall be entitled to all the privileges and advantages of
11 the public schools to which they are assigned by the local boards of education.

12 (b) It is the policy of the State that every child of a homeless individual and every
13 homeless child shall have access to a free, appropriate public education on the same
14 basis as all children who are domiciled in this State. The local board of education of the
15 school administrative unit in which the child is actually living shall enroll the child in
16 that school administrative unit. In no event shall the child be denied enrollment because
17 of uncertainty regarding the child's domiciliary status, regardless of whether the child is
18 living with the homeless parents or has been temporarily placed elsewhere by the
19 parents. The local board shall not charge the homeless child, as defined in this
20 subsection, tuition for enrollment.

21 In the event the local board of education denies enrollment to the child, the child's
22 parent, guardian, or person standing in loco parentis to the child may, within 10 days
23 after notification of the denial, apply in writing to the local board for reconsideration of
24 the decision. Written notification of the board's decision shall be delivered to the
25 applicant in person. If the reconsideration is denied, the applicant shall have a right of
26 appeal on the question of the child's enrollment in accordance with the hearing
27 procedures set out in G.S. 115C-369 and G.S. 115C-370, however, written notification
28 of all decisions shall be delivered to the applicant in person.

29 As used in this subsection, the term 'homeless' refers to an individual who (i) lacks
30 a fixed, regular, and adequate nighttime residence or (ii) has a primary nighttime
31 residence in a supervised publicly or privately operated shelter for temporary
32 accommodations, an institution providing temporary residence for individuals intended
33 to be institutionalized, or a public or private place not designated for, or ordinarily used
34 as, a regular sleeping accommodation for human beings. The term does not include
35 persons who are imprisoned or otherwise detained pursuant to federal or State law.

36 (c) The following persons under the age of 21 years who actually live in a North
37 Carolina school administrative unit for reasons other than to attend school or to
38 participate in school athletics, and who have neither been removed from school for
39 cause, nor obtained a high school diploma, shall be entitled to attend public schools on
40 the same basis as children who are domiciled in a school administrative unit in this
41 State:

42 (1) Persons under the care, custody, control, and supervision of an
43 institution established, operated, or incorporated for the purpose of

1 rearing and caring for children who do not live with their parents. This
2 subdivision includes foster homes and group homes.

3 (2) Persons living with a parent, guardian, or custodian who is a student,
4 employee, or faculty member, of a college or university, or a visiting
5 scholar at the National Humanities Center.

6 (3) Persons residing on federal property located in the State with a parent,
7 guardian, or custodian who is employed on federal property, or
8 assigned to active duty in the uniformed services.

9 (4) Persons residing on Indian lands located in the State with a parent,
10 guardian, or custodian.

11 (5) Persons living with a parent, guardian, or custodian who is a migrant
12 agricultural worker as defined in G.S. 130A-417(2).

13 (6) Persons living with and under the care, control, and supervision of a
14 domiciliary of the school unit provided that domiciliary provides
15 substantial support for the person. Local boards shall require persons
16 admitted under this subdivision to provide, on a yearly basis:

17 a. An education power of attorney in accordance with Article 4 of
18 Chapter 32A; or

19 b. A notarized affidavit as set out in G.S. 115C-364.2 by the
20 person enrolling the child if a child's parents, guardian, or
21 custodian is unknown, or cannot be found after reasonable
22 investigation, or is unwilling or unable to sign an education
23 power of attorney due to death, serious illness, incarceration or,
24 abandonment of the child. The local school board shall notify
25 the county office of social services of any child admitted in
26 accordance with this subdivision.

27 For purposes of this subsection a 'guardian' or 'custodian' is a person or agency that
28 has been awarded legal guardianship or legal custody by a court.

29 (d) Any child who is qualified under the laws of this State for admission to a
30 public school and who has a place of residence in a local school administrative unit
31 incident to his or her parent's or guardian's service in the General Assembly, other than
32 the local school administrative unit in which the child is domiciled, is entitled to attend
33 school in the local school administrative unit of that residence as if the child were
34 domiciled there, subject to the payment of applicable out-of-county fees.

35 (e) Each local board of education shall assign to a public school each student
36 qualified for assignment under this section. Except as otherwise provided by law, and
37 particularly the provisions of G.S. 115C-369 and G.S. 115C-370, the authority of each
38 board of education in the matter of assignment of children to the public schools shall be
39 full and complete, and its decision as to the assignment of any child to any school shall
40 be final.

41 (f) A student domiciled in one local school administrative unit may be assigned
42 either with or without the payment of tuition to a public school in another local school
43 administrative unit upon the terms and conditions agreed to in writing between the local
44 boards of education involved and entered in the official records of the boards. The

1 assignment shall be effective only for the current school year, but may be renewed
2 annually in the discretion of the boards involved. The assignment of students living in
3 one local school administrative unit or district to a school located in another local school
4 administrative unit or district, shall have no effect upon the right of the local school
5 administrative unit or district to which the students are assigned to levy and collect any
6 supplemental tax heretofore or hereafter voted in that local school administrative unit or
7 district.

8 (g) The boards of education of adjacent local school administrative units may
9 operate schools in adjacent units upon written agreements between the respective boards
10 of education and approval by the county commissioners and the State Board of
11 Education.

12 (h) This section shall not be construed to allow students to transfer from one
13 local school administrative unit to another for athletic participation purposes in violation
14 of eligibility requirements established by the State Board of Education and the North
15 Carolina High School Athletic Association."

16 Sec. 5. Chapter 32A is amended by adding a new Article to read:

17 **"ARTICLE 4.**

18 **"EDUCATION POWERS OF ATTORNEY.**

19 **"§ 32A-30. General purpose of this section.**

20 The purpose of this Article is to establish a method by which a parent or legal
21 guardian who has legal and physical custody of a child may give to an agent the power
22 to make any and all educational decisions concerning the child.

23 **"§ 32A-31. Definitions.**

24 As used in this Article, unless the context clearly requires otherwise, the following
25 terms have the meanings specified:

26 (1) 'Educational decisions' means any decision concerning the instruction,
27 supervision, or service provided for the education of a principal's child
28 including enrolling the child in school and signing any school-related
29 documents, including individual education plans, report cards, and
30 permission slips.

31 (2) 'Education agent' means the person appointed as an education attorney-
32 in-fact.

33 (3) 'Education power of attorney' means a written instrument, signed in the
34 presence of two qualified witnesses, and acknowledged before a notary
35 public, pursuant to which an attorney-in-fact or agent is appointed to
36 act for the principal in matters relating to the education of a child of
37 the principal, and which substantially meets the requirements of this
38 Article.

39 (4) 'Principal' means the parent or legal guardian having physical and legal
40 custody of the child making the education power of attorney.

41 (5) 'Qualified witness' means a witness in whose presence the principal
42 has executed the education power of attorney, and who believes the
43 principal to be of sound mind.

44 **"§ 32A-32. Who may make an education power of attorney.**

1 Any parent or legal guardian having legal and physical custody of a child may make
2 an education power of attorney. Legal custody is custody granted by a court of
3 competent jurisdiction. Whenever possible, the parent or legal guardian making the
4 education power of attorney shall notify any other parent or guardian of the child.

5 **"§ 32A-33. Who may act as an education attorney-in-fact.**

6 Any competent person 18 years of age or older, who is domiciled in a school
7 administrative unit and who provides a home, care, control, supervision, and substantial
8 support for the child of the principal may act as an education agent. The education
9 agent's notarized acceptance of the agency shall be included in an education power of
10 attorney.

11 **"§ 32A-34. Extent of authority; limitations of authority.**

12 (a) A principal, pursuant to an education power of attorney, may grant to the
13 education agent full power and authority to make education decisions to the same extent
14 that the principal could make those decisions for his or her child, including, without
15 limitation, the power to enroll the child in school, approve an individual education plan,
16 sign report cards, and grant permission to attend school functions and outings.

17 (b) The powers and authority granted to the education agent pursuant to an
18 education power of attorney shall be limited to the matters addressed in it and shall not
19 confer any power or authority with respect to the property or financial affairs of the
20 principal.

21 (c) This Article shall not be construed to invalidate a power of attorney that
22 authorizes an agent to make education decisions for the principal's child which was
23 executed prior to October 1, 1993.

24 **"§ 32A-35. Effectiveness and duration; revocation.**

25 (a) An education power of attorney shall become effective when signed by the
26 principal in accordance with this section. It shall be valid for no more than one year. It
27 may be revoked at any time by the principal.

28 The principal may exercise such right of revocation by executing and
29 acknowledging an instrument of revocation, by executing and acknowledging a
30 subsequent education power of attorney, or in any other written manner by which the
31 principal is able to communicate his or her intent to revoke. Such revocation shall
32 become effective only upon communication by the principal to each education agent
33 named in the revoked education power of attorney and to the school administrative unit
34 where the child named in the power of attorney attends school.

35 **"§ 32A-36. Relation of the education agent to a court-appointed fiduciary and to a**
36 **general attorney-in-fact.**

37 (a) If, following the execution of an education power of attorney, a court of
38 competent jurisdiction appoints a guardian of the person of the principal or a general
39 guardian with powers over the person of the principal, the education power of attorney
40 shall cease to be effective upon the appointment and qualification of the guardian. If,
41 following the execution of an education power of attorney, a court of competent
42 jurisdiction appoints a guardian of the person of the principal's child, or a general
43 guardian with powers over the person of the principal's child, the education power of

1 attorney shall cease to be effective upon the appointment and qualification of the
2 guardian.

3 (b) The execution of an education power of attorney shall not revoke, restrict, or
4 otherwise affect any powers granted by the principal to an attorney-in-fact pursuant to a
5 general power of attorney; provided that the powers granted to the education agent with
6 respect to the education of the principal's child shall be superior to any similar powers
7 granted by the principal to an attorney-in-fact under a general power of attorney.

8 (c) An education power of attorney may be combined with or incorporated into a
9 general power of attorney which is executed in accordance with the requirements of this
10 Article.

11 **"§ 32A-37. Reliance on education power of attorney; defense.**

12 (a) Any education provider involved in the education of the principal's child may
13 rely upon the authority of the education agent contained in a signed and acknowledged
14 education power of attorney in the absence of actual knowledge of revocation of the
15 education power of attorney.

16 (b) Any education provider relying in good faith on the authority of an education
17 agent shall be protected to the full extent of the power conferred upon the education
18 agent, and no person so relying on the authority of the education agent shall be liable,
19 by reason of his or her reliance, for actions taken pursuant to a decision of the education
20 agent.

21 **"§ 32A-38. Statutory form education power of attorney.**

22 The use of the following form in the creation of an education power of attorney is
23 lawful and, when used, it shall meet the requirements of and be construed in accordance
24 with the provisions of this Article:

25 '(Notice: This document gives the person you designate your education agent broad
26 powers to make education decisions for your child. Because the powers granted by this
27 document are broad and sweeping, you should discuss your wishes concerning your
28 child's education with your education agent.

29 Use of this form in the creation of an education power of attorney is lawful and is
30 authorized pursuant to North Carolina law. However, use of this form is an optional and
31 nonexclusive method for creating an education power of attorney, and North Carolina
32 law does not bar the use of any other or different form of power of attorney that meets
33 the statutory requirements.)

34 1. Designation of education agent.

35 I,....., being of sound mind, hereby appoint:

10 Each successor education agent designated shall be vested with the same power and
11 duties as if originally named as my education agent.

12 2. Effectiveness of appointment.

13 (Notice: This education power of attorney may be revoked by you at any time in any
14 written manner by which you are able to communicate your intent to revoke to your
15 education agent and your child's school administrative unit.)

16 Absent revocation, the authority granted in this document shall be effective for one
17 year.

18 3. General statement of authority granted.

19 Except as indicated in section 4 below, I hereby grant to my education agent named
20 above full power and authority to make decisions regarding the education, care, control,
21 and supervision of my child. Educational decisions on behalf of my child shall include
22 enrolling my child in school and signing any school-related documents including
23 individual education plans, report cards, and permission slips.

24 My education agent may take any lawful actions that may be necessary to carry out
25 these decisions, including the granting of releases of liability to service providers.

26 4. Special provisions and limitations.

27 (Notice: The above grant of power is intended to be as broad as possible so that your
28 education agent will have authority to make any decisions you could make to obtain or
29 terminate any type of education services for your child. If you wish to limit the scope of
30 your education agent's powers, you may do so in this section.)

31 In exercising the authority to make education decisions for my child on my behalf,
32 the authority of my education agent is subject to the following special provisions and
33 limitations (Here you may include any specific limitations you deem appropriate.):

42 5. Reliance of third parties on education agent.

43 A. No person who relies in good faith upon the authority of or any
44 representations by my education agent shall be liable to me, my estate,

1 my heirs, successors, assigns, or personal representatives, for actions
2 or omissions by my education agent.

3 B. The powers conferred on my education agent by this document may be
4 exercised by my education agent alone, and my education agent's
5 signature or act under the authority granted in this document may be
6 accepted by persons as fully authorized by me and with the same force
7 and effect as if I were personally present, competent, and acting on my
8 own behalf. All acts performed in good faith by my education agent
9 pursuant to this power of attorney are done with my consent and shall
10 have the same validity and effect as if I were present and exercised the
11 powers myself, and shall inure to the benefit of and bind me, my
12 estate, my heirs, successors, assigns, and personal representatives.

13 6. Miscellaneous provisions.

14 A. I revoke any prior education power of attorney.

15 B. My education agent shall be entitled to sign, execute, deliver, and
16 acknowledge any contract or other document that may be necessary,
17 desirable, convenient, or proper in order to exercise and carry out any
18 of the powers described in this document. However, under no
19 circumstances shall my education agent have any authority over my
20 property or financial affairs.

21 C. My education agent and my education agent's estate, heirs, successors,
22 and assigns are hereby released and forever discharged by me, my
23 estate, my heirs, successors, and assigns and personal representatives
24 from all liability and from all claims or demands of all kinds arising
25 out of the acts or omissions of my education agent pursuant to this
26 document, except for willful misconduct or gross negligence.

27 7. Signature of principal.

28 By signing here, I indicate that I am mentally alert and competent, fully informed as
29 to the contents of this document, and understand the full import of this grant of powers
30 to my education agent.

Sec. 6. Subdivision (9) of G.S. 32A-2 reads as rewritten:

"(9) Personal Relationships and Affairs. – To do all acts necessary for maintaining the customary standard of living of the principal, the spouse and children, and other dependents of the principal; to provide medical, dental and surgical care, hospitalization and custodial care for the principal, the spouse, and children, and other dependents of the principal; to continue whatever provision has been made by the principal, for the principal, the spouse, and children, and other dependents of the principal, with respect to automobiles, or other means of transportation; to continue whatever charge accounts have been operated by the principal, for the convenience of the principal, the spouse, and children, and other dependents of the principal, to open such new accounts as the attorney-in-fact shall think to be desirable for

the accomplishment of any of the purposes enumerated in this section, and to pay the items charged on such accounts by any person authorized or permitted by the principal or the attorney-in-fact to make such charges; to continue the discharge of any services or duties assumed by the principal, to any parent, relative or friend of the principal; to continue payments incidental to the membership or affiliation of the principal in any church, club, society, order or other organization, or to continue contributions thereto.

In the event the attorney-in-fact named pursuant to G.S. 32A-1 makes a decision regarding the health care of the principal that is contradictory to a decision made by a health care agent appointed pursuant to Article 3 of this Chapter, the decision of the health care agent shall overrule the decision of the attorney-in-fact.

In the event the attorney-in-fact named pursuant to G.S. 32A-1 makes a decision regarding the education of a child of the principal that is contradictory to a decision made by an education agent appointed pursuant to Article 4 of this Chapter the decision of the education agent shall overrule the decision of the attorney-in-fact."

Sec. 7. Article 25 of Chapter 115C is amended by adding a new section to read:

"§ 115C-364.2. Affidavit for school attendance.

Sec. 8. G.S. 115C-366.1 reads as rewritten:

"§ 115C-366.1. Local boards of education; tuition charges.

(a) Local boards of education may admit and may charge tuition ~~to~~ for the following persons:

- (1) Persons of school age who are not domiciliaries of the State—State and who are not entitled to attend North Carolina schools in accordance with G.S. 115C-364.1(b) or (c). The tuition charge for these students shall not exceed the amount of per pupil local and State funding. These

1 persons shall not be included in the average daily membership of the
2 local school administrative unit for the purpose of allocating State
3 funds: Provided, persons who live in a household in a state bordering
4 North Carolina in which at least fifty-one percent (51%) of the gross
5 household income is derived from a business, trade, profession, or
6 occupation carried on in this State may be admitted by the local board
7 of education, and, if admitted, shall be included in the average daily
8 membership of the local school administrative unit for the purpose of
9 allocating State funds. The tuition charge for these persons may not
10 exceed the amount of the local supplement.

11 (2) Persons of school age who are domiciliaries of the State but who do
12 not reside within the school administrative unit or district unit, and who
13 are not entitled to attend North Carolina schools in accordance with
14 G.S. 115C-364.1(b) or (c). This subdivision applies to students
15 admitted in accordance with G. S. 115C-364.1(f). The tuition charge
16 for these students shall not exceed the amount of per pupil local
17 funding.

18 (3) ~~Persons of school age who reside on a military or naval reservation~~
19 ~~located within the State and who are not domiciliaries of the State.~~
20 ~~Provided, however, that no person of school age residing on a military~~
21 ~~or naval reservation located within the State and who attends the~~
22 ~~public schools within the State may be charged tuition if federal funds~~
23 ~~designed to compensate for the impact on public schools of military~~
24 ~~dependent persons of school age are funded by the federal government~~
25 ~~at not less than fifty percent (50%) of the total per capita cost of~~

29 (4) ~~Persons who are 21 years of age or older before the beginning of the~~

33 ~~(c) The tuition required in this section shall be determined by local boards of~~
34 ~~education each August 1 prior to the beginning of a new school year. Persons subject to~~
35 ~~tuition charges shall be notified of the current local amount and the prior year's State~~
36 ~~amount as soon as possible but no later than that person's entering the school system.~~
37 ~~Persons subject to State tuition shall be notified of the current amount as soon as~~
38 ~~possible after the tenth school day of the current school year."~~

39 Sec. 9. G.S. 115C-113.1 reads as rewritten:

41 In the case of a child whose parent or guardian is unknown, whose whereabouts
42 cannot be determined after reasonable investigation, or who is a ward of the State, the
43 local educational agency shall appoint a surrogate parent for the child. ~~The~~ An education
44 agent enrolling a child pursuant to G.S. 115C-364.1(c)(6) shall be named the surrogate

1 parent. In other cases the surrogate parent shall be appointed from a group of persons
2 approved by the Superintendent of Public Instruction and the Secretary of Human
3 Resources, but in no case shall the person appointed be an employee of the local
4 educational agency or directly involved in the education or care of the child. The
5 Superintendent shall ensure that local educational agencies appoint a surrogate parent
6 for every child in need of a surrogate parent."

7 Sec. 10. The State Board of Education shall promulgate rules and regulations
8 to administer this act, and in particular Section 8 of this act, no later than October 1,

10 Sec. 11. The Department of Public Instruction shall report to the Joint
11 Legislative Education Oversight Committee on January 15, 1994, and every year
12 thereafter on how Section 8 of this act is being administered and on the number of
