1 A BILL TO BE ENTITLED  
2 AN ACT TO PROVIDE FOR UNIFORM DRIVERS LICENSE AND VEHICLE  
3 REGISTRATION INFORMATION.

4 The General Assembly of North Carolina enacts:

5 Section 1. G.S. 20-7 reads as rewritten:

6 "**§ 20-7. Issuance and renewal of drivers licenses.**

7 (a) License Required. – To drive a motor vehicle on a highway, a person must be  
8 licensed by the Division under this Article or Article 2C of this Chapter to drive ~~that~~  
9 ~~vehicle.~~ the vehicle and must carry the license while driving the vehicle. The Division  
10 issues regular drivers licenses under this Article and issues commercial drivers licenses  
11 under Article 2C.

12 A license authorizes the holder of the license to drive any vehicle included in the  
13 class of the license and any vehicle included in a lesser class of license, except a vehicle  
14 for which an endorsement is required. To drive a vehicle for which an endorsement is  
15 required, a person must obtain both a license and an endorsement for the vehicle. A  
16 regular drivers license is considered a lesser class of license than its commercial  
17 counterpart.

18 The classes of regular drivers licenses and the motor vehicles that can be driven with  
19 each class of license are:

20 (1) Class A. – A Class A license authorizes the holder to drive any of the  
21 following:

22 a. A Class A motor vehicle that is exempt under G.S. 20-37.16  
23 from the commercial drivers license requirements.

- 1                   b.     A Class A motor vehicle that has a combined GVWR of less  
2                   than 26,001 pounds and includes as part of the combination a  
3                   towed unit that has a GVWR of at least 10,001 pounds.
- 4           (2)     Class B. – A Class B license authorizes the holder to drive any Class B  
5           motor vehicle that is exempt under G.S. 20-37.16 from the commercial  
6           drivers license requirements.
- 7           (3)     Class C. – A Class C license authorizes the holder to drive any of the  
8           following:
- 9           a.     A Class C motor vehicle that is not a commercial motor vehicle.
- 10           b.     When operated by a volunteer member of a fire department, a  
11           rescue squad, or an emergency medical service (EMS) in the  
12           performance of duty, a Class A or Class B fire-fighting, rescue,  
13           or EMS motor vehicle or a combination of these vehicles.

14           The Commissioner may assign a unique motor vehicle to a class that is different  
15           from the class in which it would otherwise belong.

16           A new resident of North Carolina who has a drivers license issued by another  
17           jurisdiction must obtain a license from the Division within 30 days after becoming a  
18           resident.

19           (a1)   Motorcycles and Mopeds. – To drive a motorcycle, a person must have a  
20           drivers license and a motorcycle endorsement. To obtain a motorcycle endorsement, a  
21           person must demonstrate competence to drive a motorcycle by passing a road test and a  
22           written or oral test concerning a motorcycle and must pay the fee for a motorcycle  
23           endorsement. Neither a drivers license nor a motorcycle endorsement is required to  
24           drive a moped.

25           (b)    Repealed by Session Laws 1993, c. 368, s. 1, c. 533, s. 12, effective January  
26           1, 1995.

27           ~~(e)    (b1) Application and Tests. Application. – To obtain a drivers license from the~~  
28           Division, a person must complete an application form provided by the Division, present  
29           at least two forms of identification approved by the Commissioner, be a resident of this  
30           State, and demonstrate his or her physical and mental ability to drive safely a motor  
31           vehicle included in the class of license for which the person has applied. The Division  
32           may copy the identification presented or hold it for a brief period of time to verify its  
33           ~~authenticity. To authenticity. To obtain an endorsement, a person must demonstrate his~~  
34           or her physical and mental ability to drive safely the type of motor vehicle for which the  
35           endorsement is required. ~~The Division shall note an endorsement on the face of a drivers~~  
36           license.

37           The application form must request all of the following information and may request  
38           other information the Division considers necessary:

- 39           (1)    The applicant's full name.
- 40           (2)    The applicant's mailing address and residence address.
- 41           (3)    A physical description of the applicant, including the applicant's sex,  
42           height, eye color, and hair color.
- 43           (4)    The applicant's date of birth.
- 44           (5)    The applicant's social security number.

1           (6) The applicant's signature.

2 The application form must also contain the disclosures concerning the request for an  
3 applicant's social security number required by section 7 of the federal Privacy Act of  
4 1974, Pub. L. No. 93-579.

5           (c) Tests. – To demonstrate physical and mental ability, a person must pass an  
6 examination. The examination may include road tests, vision tests, oral tests, and, in the  
7 case of literate applicants, written tests, as the Division may require. The tests must  
8 ensure that an applicant recognizes the handicapped international symbol of access, as  
9 defined in G.S. 20-37.5. The Division may not require a person who applies to renew a  
10 license that has not expired to take a written test or a road test unless one or more of the  
11 following applies:

12           (1) The person has been convicted of a traffic violation since the person's  
13 license was last issued.

14           (2) The applicant suffers from a mental or physical condition that impairs  
15 the person's ability to drive a motor vehicle.

16           The Division may not require a person who is at least 60 years old to parallel park a  
17 motor vehicle as part of a road test.

18           (c1) Insurance. – The Division may not issue a drivers license to a person until the  
19 person has furnished proof of financial responsibility. Proof of financial responsibility  
20 shall be in one of the following forms:

21           (1) A written certificate or electronically-transmitted facsimile thereof  
22 from any insurance carrier duly authorized to do business in this State  
23 certifying that there is in effect a nonfleet private passenger motor  
24 vehicle liability policy for the benefit of the person required to furnish  
25 proof of financial responsibility. The certificate or facsimile shall state  
26 the effective date and expiration date of the nonfleet private passenger  
27 motor vehicle liability policy and shall state the date that the certificate  
28 or facsimile is issued. The certificate or facsimile shall remain  
29 effective proof of financial responsibility for a period of 30  
30 consecutive days following the date the certificate or facsimile is  
31 issued but shall not in and of itself constitute a binder or policy of  
32 insurance.

33           (2) A binder for or policy of nonfleet private passenger motor vehicle  
34 liability insurance under which the applicant is insured, provided that  
35 the binder or policy states the effective date and expiration date of the  
36 nonfleet private passenger motor vehicle liability policy.

37           The preceding provisions of this subsection do not apply to applicants who do not  
38 own currently registered motor vehicles and who do not operate nonfleet private  
39 passenger motor vehicles that are owned by other persons and that are not insured under  
40 commercial motor vehicle liability insurance policies. In such cases, the applicant shall  
41 sign a written certificate to that effect. Such certificate shall be furnished by the  
42 Division and may be incorporated into the license application form. Any material  
43 misrepresentation made by such person on such certificate shall be grounds for  
44 suspension of that person's license for a period of 90 days.

1 For the purpose of this subsection, the term 'nonfleet private passenger motor  
2 vehicle' has the definition ascribed to it in Article 40 of General Statute Chapter 58.

3 The Commissioner may require that certificates required by this subsection be on a  
4 form approved by the Commissioner.

5 The requirement of furnishing proof of financial responsibility does not apply to a  
6 person who applies for a renewal of his drivers license and who is not required to take  
7 the written examination.

8 Nothing in this subsection precludes any person from showing proof of financial  
9 responsibility in any other manner authorized by Articles 9A and 13 of this Chapter.

10 (d) Repealed by Session Laws 1993, c. 368, s. 1, effective January 1, 1995.

11 (e) Restrictions. – The Division may impose any restriction it finds advisable on  
12 a drivers license. ~~A restriction shall be noted on the face of the license.~~ It is unlawful for  
13 the holder of a restricted license to operate a motor vehicle without complying with the  
14 restriction and is the equivalent of operating a motor vehicle without a license. If any  
15 applicant shall suffer from any physical defect or disease which affects his or her  
16 operation of a motor vehicle, the Division may require to be filed with it a certificate of  
17 such applicant's condition signed by some medical authority of the applicant's  
18 community designated by the Division. This certificate shall in all cases be treated as  
19 confidential. Nothing in this subsection shall be construed to prevent the Division from  
20 refusing to issue a license, either restricted or unrestricted, to any person deemed to be  
21 incapable of safely operating a motor vehicle. This subsection does not prohibit deaf  
22 persons from operating motor vehicles who in every other way meet the requirements of  
23 this section.

24 (f) Expiration and Temporary License. – The first drivers license the Division  
25 issues to a person expires on the person's fourth or subsequent birthday that occurs after  
26 the license is issued and on which the individual's age is evenly divisible by five, unless  
27 this subsection sets a different expiration date. The first drivers license the Division  
28 issues to a person who is at least 17 years old but is less than 18 years old expires on the  
29 person's twentieth birthday. The first drivers license the Division issues to a person who  
30 is at least 62 years old expires on the person's birthday in the fifth year after the license  
31 is issued, whether or not the person's age on that birthday is evenly divisible by five.

32 A drivers license that was issued by the Division and is renewed by the Division  
33 expires five years after the expiration date of the license that is renewed. A person may  
34 apply to the Division to renew a license during the 60-day period before the license  
35 expires. The Division may not accept an application for renewal made before the 60-  
36 day period begins.

37 Any person serving in the armed forces of the United States on active duty and  
38 holding a valid drivers license properly issued under this section and stationed outside  
39 the State of North Carolina may renew the license by making application to the Division  
40 by mail. Any other person, except a nonresident, who holds a valid drivers license  
41 issued under this section and who is temporarily residing outside North Carolina, may  
42 also renew by making application to the Division by mail. For purposes of this section  
43 'temporarily' shall mean not less than 30 days continuous absence from North Carolina.  
44 In either case, the Division may waive the examination and color photograph otherwise

1 required for the renewal of a drivers license, and may impose in lieu thereof any  
 2 conditions it considers appropriate to each particular application. A license renewed by  
 3 mail is a temporary license that expires 30 days after the person to whom it is issued  
 4 returns to this State.

7 (i) Fees. – The fee for a regular drivers license is the amount set in the following  
 8 table multiplied by the number of years in the period for which the license is issued:

13	Class C	2.50

14  
 15 The fee for a motorcycle endorsement is one dollar and twenty-five cents (\$1.25) for  
 16 each year of the period for which the endorsement is issued. The appropriate fee must  
 17 be paid before a person receives a regular drivers license or an endorsement.

18 (i1) Restoration Fee. – Any person whose drivers license has been revoked  
 19 pursuant to the provisions of this Chapter, other than G.S. 20-17(2), shall pay a  
 20 restoration fee of twenty-five dollars (\$25.00). A person whose drivers license has been  
 21 revoked under G.S. 20-17(2) shall pay a restoration fee of fifty dollars (\$50.00) until the  
 22 end of the fiscal year in which the cumulative total amount of fees deposited under this  
 23 subsection in the General Fund exceeds five million dollars (\$5,000,000), and shall pay  
 24 a restoration fee of twenty-five dollars (\$25.00) thereafter. The fee shall be paid to the  
 25 Division prior to the issuance to such person of a new drivers license or the restoration  
 26 of the drivers license. The restoration fee shall be paid to the Division in addition to any  
 27 and all fees which may be provided by law. This restoration fee shall not be required  
 28 from any licensee whose license was revoked or voluntarily surrendered for medical or  
 29 health reasons whether or not a medical evaluation was conducted pursuant to this  
 30 Chapter. The twenty-five dollar (\$25.00) fee, and the first twenty-five dollars (\$25.00)  
 31 of the fifty-dollar (\$50.00) fee, shall be deposited in the Highway Fund. The remaining  
 32 twenty-five dollars (\$25.00) of the fifty-dollar (\$50.00) fee shall be deposited in the  
 33 General Fund of the State. The Office of State Budget and Management shall certify to  
 34 the Department of Transportation and the General Assembly when the cumulative total  
 35 amount of fees deposited in the General Fund under this subsection exceeds five million  
 36 dollars (\$5,000,000), and shall annually report to the General Assembly the amount of  
 37 fees deposited in the General Fund under this subsection.

38 It is the intent of the General Assembly to annually appropriate the funds deposited  
 39 in the General Fund under this subsection to the Board of Governors of The University  
 40 of North Carolina to be used for the Center for Alcohol Studies Endowment at The  
 41 University of North Carolina at Chapel Hill, but not to exceed this cumulative total of  
 42 five million dollars (\$5,000,000).

43 (j) Highway Fund. – The fees collected under this section and G.S. 20-14 shall  
 44 be placed in the Highway Fund.

2 (l) Learner's Permit. – Any person who except for lack of instruction in  
3 operating a motor vehicle would be qualified to obtain a drivers license under this  
4 Article may obtain a learner's permit. A learner's permit authorizes the permit holder to  
5 drive a specified type or class of motor vehicle while in possession of the permit. A  
6 learner's permit is valid for a period of 18 months after it is issued. The fee for a  
7 learner's permit is ten dollars (\$10.00). A learner's permit may be renewed, or a second  
8 learner's permit may be issued, for an additional period of 18 months. The permit  
9 holder must, while operating a motor vehicle over the highways, be accompanied by a  
10 person who is licensed to operate the motor vehicle being driven and is seated beside  
11 the permit holder.

12 (l-1) Repealed by Session Laws 1991, c. 726, s. 5, effective October 1, 1991.

13 (m) Instruction Permit. – The Division upon receiving proper application may in  
14 its discretion issue a restricted instruction permit effective for a school year or a lesser  
15 period to any of the following applicants:

16 (1) An applicant who is less than 18 years old and is enrolled in a drivers  
17 education program that is approved by the State Superintendent of  
18 Public Instruction and is offered at a public high school, a nonpublic  
19 secondary school, or a licensed drivers training school.

20 (2) An applicant for certification under G.S. 20-218 as a school bus driver.  
21 A restricted instruction permit authorizes the holder of the permit to drive a specified  
22 type or class of motor vehicle when in possession of the permit, subject to any  
23 restrictions imposed by the Division. The restrictions the Division may impose on a  
24 permit include restrictions to designated areas and highways and restrictions prohibiting  
25 operation except when an approved instructor is occupying a seat beside the permittee.  
26 A restricted instruction permit is not required to have a distinguishing number or a  
27 picture of the person to whom the permit is issued.

28 (n) Format. —~~Every A~~ drivers license issued by the Division shall bear thereon  
29 ~~the distinguishing number assigned to the licensee and color photograph of the licensee~~  
30 ~~of a size approved by the Commissioner and shall contain the name, age, residence~~  
31 ~~address and a brief description of the licensee, who, for the purpose of identification and~~  
32 ~~as a condition precedent to the validity of the license, immediately upon receipt thereof,~~  
33 ~~shall endorse his or her regular signature in ink upon the same in the space provided for~~  
34 ~~that purpose unless a facsimile of his or her signature appears thereon; provided the~~  
35 must be designed to be tamper proof, must contain all of the following information, and  
36 may contain other information the Commissioner considers necessary:

37 (1) An identification of this State as the issuer of the license.

38 (2) The license holder's full name.

39 (3) The license holder's residence address.

40 (4) A color photograph of the license holder, taken by the Division.

41 (5) A physical description of the license holder, including sex, height, eye  
42 color, and hair color.

43 (6) The license holder's date of birth.

- 1           (7) The license holder's social security number or another identifying  
 2           number assigned by the Division.  
 3           (8) Each class of motor vehicle the license holder is authorized to drive  
 4           and any endorsements or restrictions that apply.  
 5           (9) The license holder's signature.  
 6           (10) The date the license was issued and the date the license expires.

7           The Commissioner may waive the requirement that of a color photograph of the  
 8 licensee appear on the a license may be waived by the Commissioner upon satisfactory proof  
 9 if the license holder proves to the satisfaction of the Commissioner that the taking of  
 10 such the photograph violates would violate the license holder's religious convictions of the  
 11 licensee. Drivers licenses shall be issued with differing color photographic backgrounds  
 12 according to the licensee's age at time of issuance for the following age groups:

- 13           (1) Persons who have not attained the age of 21 years.  
 14           (2) Persons who have attained the age of 21 years.

15 convictions. In taking photographs of license holders, the Division must distinguish  
 16 between license holders who are less than 21 years old and license holders who are at  
 17 least 21 years old by using different color backgrounds for each group. The Division  
 18 shall determine the different colors to be used. Such license shall be carried by the licensee  
 19 at all times while engaged in the operation of a motor vehicle.

 21           Sec. 2. G.S. 20-37.7 reads as rewritten:

22 **"§ 20-37.7. Special identification card.**

23           (a) Eligibility. The Division of Motor Vehicles shall upon satisfactory proof of  
 24 identification issue a special identification card to any person 11 years or older who is a  
 25 resident of the State of North Carolina. A person who is a resident of this State, is at  
 26 least 11 years old, and does not have a drivers license is eligible for a special  
 27 identification card.

28           (b) Application. Every application for a special identification card shall be made  
 29 on the approved form furnished by the Division and shall be accompanied by a birth  
 30 certificate and other proof of identification which shall be returned when the special  
 31 identification card is issued. To obtain a special identification card from the Division, a  
 32 person must complete the application form used to obtain a drivers license.

33           (c) Format. Special A special identification cards shall be issued with differing  
 34 color photographic backgrounds according to the holder's age at time of issuance for the  
 35 following age groups:

- 36           (1) Persons who have not attained the age of 21 years.  
 37           (2) Persons who have attained the age of 21 years.

38 The card shall be similar in size, shape, and design to a driver's drivers license, but shall  
 39 clearly state that it does not entitle the person to whom it is issued to operate a motor  
 40 vehicle. A special identification card issued to an applicant must have the same  
 41 background color that a drivers license issued to the applicant would have.

42           (d) Expiration and Fee. A special identification card issued to a person for the  
 43 first time under this section expires when a drivers license issued on the same day to  
 44 that person would expire. A special identification card renewed under this section

1 expires when a drivers license renewed by the card holder on the same day would  
2 expire.

3 The fee for a special identification card is the same as the fee set in G.S. 20-14 for a  
4 duplicate license. The fee does not apply to a special identification card issued to a  
5 resident of this State who is legally blind, is at least 70 years old, or is homeless. To  
6 obtain a special identification card without paying a fee, a homeless person must present  
7 a letter to the Division from the director of a facility that provides care or shelter to  
8 homeless persons verifying that the person is homeless.

9 (e) Offense. – Any fraud or misrepresentation in the application for or use of a  
10 special identification card issued under this section is a Class 2 misdemeanor.

11 (f) Records. – ~~The Division of Motor Vehicles shall maintain a record of all~~  
12 ~~recipients of a special identification card. The Division may promulgate any rules and~~  
13 ~~regulations it deems necessary for the effective implementation of the provisions of this~~  
14 ~~section.~~

15 (g) No State Liability. – The fact of issuance of a special identification card  
16 pursuant to this section shall not place upon the State of North Carolina or any agency  
17 thereof any liability for the misuse thereof and the acceptance thereof as valid  
18 identification is a matter left entirely to the discretion of any person to whom such card  
19 is presented.

20 (h) Advertising. – The Division may utilize the various communications media  
21 throughout the State to inform North Carolina residents of the provisions of this  
22 section."

23 Sec. 3. G.S. 20-37.15(a) reads as rewritten:

24 "(a) ~~The application for a commercial drivers license must include the following:~~

- 25 (1) ~~The full name, current mailing address, and current residence address~~  
26 ~~of the applicant;~~
- 27 (2) ~~A physical description of the person including sex, height, and eye and~~  
28 ~~hair color;~~
- 29 (3) ~~Date of birth;~~
- 30 (4) ~~The applicant's social security number;~~
- 31 (5) ~~The applicant's signature;~~
- 32 (6) ~~Repealed by Session Laws 1991, c. 726, s. 17.~~
- 33 (7) ~~Certifications including those required by 49 C.F.R. § 383.71(a);~~

36 An application for a commercial drivers license must include the information  
37 required by G.S. 20-7 for a regular drivers license and a consent to release driving  
38 record information."

39 Sec. 4. G.S. 20-37.16(a) reads as rewritten:

40 "(a) A commercial drivers license must be marked 'Commercial Drivers License'  
41 or 'CDL' and shall, ~~to the maximum extent practicable, be tamper proof. It must~~  
42 ~~include:~~

- 43 (1) ~~The person's name and residential address;~~
- 44 (2) ~~The person's color photograph;~~



- 1           (3) ~~A physical description of the person including sex, height, eye color,~~  
2           ~~and hair color;~~
- 3           (4) ~~The person's date of birth;~~
- 4           (5) ~~The person's social security number or any number or identifier~~  
5           ~~deemed appropriate by the Division;~~
- 6           (6) ~~The person's signature;~~

11 'CDL' and must contain the information required by G.S. 20-7 for a regular drivers  
12 license."

13           Sec. 5. G.S. 20-52(a) reads as rewritten:

14           "(a) Every~~An~~ owner of a vehicle subject to registration hereunder shall make  
15 application to the Division for the registration thereof and issuance of~~must apply to the~~  
16 Division for a certificate of title for such vehicle upon the appropriate form or forms  
17 furnished by the Division, and every such application shall bear the signature of the  
18 owner written with pen and ink, and said signature shall be acknowledged by the owner  
19 before a person authorized to administer oaths, and said application shall contain: title, a  
20 registration plate, and a registration card for the vehicle. To apply, an owner must  
21 complete an application form provided by the Division. The application form must  
22 request all of the following information and may request other information the Division  
23 considers necessary:

24           (1) ~~The name, bona fide residence and mail address of the owner or~~  
25           ~~business address of the owner if a firm, association or corporation;~~  
26           ~~owner's name.~~

27           (1a) If the owner is an individual, the following information:

28           a. The owner's mailing address and residence address.

29           b. The owner's social security number.

30           (1b) If the owner is a firm, a partnership, a corporation, or another entity,  
31           the address of the entity.

32           (2) ~~A description of the vehicle, including, insofar as the hereinafter~~  
33           ~~specified data may exist with respect to a given vehicle, the including~~  
34           ~~the following:~~

35           a. The make, model, type of body, the serial number of the  
36           vehicle, the engine and other identifying numbers of the vehicle  
37           and whether and vehicle identification number of the vehicle.

38           b. Whether the vehicle is new or used, and used and, if a new  
39           vehicle, the date of sale and actual date of delivery of vehicle by  
40           the manufacturer or dealer to the person intending to operate  
41           such vehicle; the manufacturer or dealer sold the vehicle to the  
42           owner and the date the manufacturer or dealer delivered the  
43           vehicle to the owner.

- 1           (3) A statement of the ~~applicant's~~ owner's title and of all liens upon the  
2           vehicle, including the names and addresses of all lienholders in the  
3           order of their priority, and the date and nature of each ~~lien~~; lien.
- 4           (4) ~~Such further information as may reasonably be required by the~~  
5           ~~Division to enable it to determine whether the vehicle is lawfully~~  
6           ~~entitled to registration and the owner entitled to a certificate of title.~~

7 The application form must contain the disclosures concerning the request for an  
8 applicant's social security number required by section 7 of the federal Privacy Act of  
9 1974, Pub. L. No. 93-579."

10           Sec. 6. This act becomes effective January 1, 1995.
