Section 1. G.S. 105-164.4(c) reads as rewritten:

6 "(c) Any person who engages in any business for which a privilege tax is imposed 7 by this Article shall apply for and obtain from the Secretary upon payment of fifteen 8 dollars (\$15.00) a license to engage in and conduct the business upon the condition that 9 the person shall pay the tax accruing to the State under this Article; the person shall 10 thereby be duly licensed and registered to engage in the business. Except as hereinafter 11 provided, a

12 A license issued under this subsection shall be a continuing license until it becomes void or is revoked for failure to comply with the provisions of this Article. A-Article. A 13 14 license issued under this section to a person, other than a person who makes only wholesale sales or only exempt sales, becomes void if-if, for a period of eighteen 15 months, the license holder ceases to be engaged in a business for which a privilege tax is 16 17 imposed by this Article and remains continuously out of business for a period of five years. 18 The burden of proving that a license is still valid is on the license holder. files no return or 19 files returns showing no sales. 20 A retailer who sells tangible personal property at a flea market shall conspicuously

- 21 display his-the retailer's sales tax license when making sales at the flea market."
