1 A BILL TO BE ENTITLED 2 AN ACT TO AUTHORIZE THE CONTINUED OPERATION OF CERTAIN 3 UNLINED MUNICIPAL SOLID WASTE LANDFILLS, AS RECOMMENDED BY 4 THE JOINT LEGISLATIVE ADMINISTRATIVE PROCEDURE OVERSIGHT 5 COMMITTEE.

6 The General Assembly of North Carolina enacts:

A person who holds a permit for an existing municipal solid waste 7 Section 1. (a) landfill that is not designed and constructed with a liner and leachate collection system 8 may continue to receive municipal solid waste for disposal in that landfill after 1 January 9 1998 and until 1 January 2003 in order to establish improved final contours of that 10 landfill if the permittee has implemented a solid waste reduction and recycling program 11 that is determined by the Department of Environment, Health, and Natural Resources, in 12 accordance with subsections (c1) and (c2) of G.S. 130A-309.04, to have reduced the 13 amount of solid waste eligible for disposal at that landfill and the Department approves 14 an amended transition plan pursuant to this act. 15

16 (b) Waste received at a municipal solid waste landfill that is authorized to continue 17 operation under this act shall be disposed of in a vertical expansion within the perimeter 18 of the area in which waste had been disposed of as of 9 October 1991. The quantity of 19 municipal solid waste received at a municipal solid waste landfill that is authorized to 20 continue operation under this act shall not exceed the quantity of municipal solid waste

1	received in the landfill between 1 July 1991 and 30 June 1996. The Department of
2	Environment, Health, and Natural Resources shall not approve an amended transition
3	plan that provides for the receipt of waste in excess of the quantity authorized by this
4	subsection.
5	(c) A permittee who is authorized to continue operation of a landfill under this act
6	shall, when closing the landfill, install a cap system that:
7	(1) Contains a composite liner consisting of two components, a compacted
8	clay liner and a geomembrane liner.
9	(2) After the waste has settled, will have final contours such that no part of
10	the cap system will have a slope of less than five percent (5%) or more
11	than twenty-five percent (25%).
12	(3) Covers all contiguous areas used for waste disposal, including
13	contiguous areas within the landfill that were used for waste disposal
14	prior to 9 October 1991.
15	(4) Complies with rules adopted by the Commission for Health Services.
16	(d) The vertical expansion of the municipal solid waste landfill shall comply with
17	all applicable federal laws and regulations.
18	(e) A permittee who is authorized to continue operation of a landfill under this
19	act shall prepare an amended transition plan, including a closure plan for the landfill, that
20	complies with this act. In preparing the amended transition plan, the permittee shall
21	comply with the public notice and participation requirements of G.S. 130A-294(b)(2) as
22	though the amended transition plan were a substantial amendment to the permit and with
23	all other requirements applicable to transition plans under Article 9 of Chapter 130A of
24	the General Statutes and rules adopted under that Article. The closure plan shall be
25	submitted to the Department for approval prior to 1 January 1997.
26	(f) A permittee who is authorized to continue operation of a landfill under this
27	act shall implement and maintain a program to minimize the amount of household
28	hazardous waste, as defined in 40 Code of Federal Regulations § 261.4(b)(1) (1 July 1995
29	Edition), that is generated by households served by the landfill and disposed of in the
30	landfill. The program shall, at a minimum:
31	(1) Provide a facility for the collection and management of household
32	hazardous waste that accepts household hazardous waste at least once a
33	month and that meets all applicable federal and State requirements.
34	(2) Include a public education component to encourage members of the
35	public to make use of the household hazardous waste program and to
36	comply with all federal and State laws, regulations, and rules relating to
37	the disposal of household hazardous waste.
38	(g) A permittee who is authorized to continue operation of a landfill under this
39	act shall also comply with the requirements of G.S. 130A-309.09B.
40	Sec. 2. This act is effective upon ratification and expires on 1 January 2003.
