February 12, 1997 A BILL TO BE ENTITLED AN ACT TO INCORPORATE THE VILLAGE OF CAROLINA TRACE. The General Assembly of North Carolina enacts: Section 1. A Charter of the Village of Carolina Trace is enacted as follows: "THE CHARTER OF THE VILLAGE OF CAROLINA TRACE. "CHAPTER I. "INCORPORATION AND CORPORATE POWERS. "Section 1-1. **Incorporation and Corporate Powers.** The inhabitants of the Village of Carolina Trace are a body corporate and politic under the name 'Village of Carolina Under that name they have all the powers, duties, rights, privileges, and immunities conferred and imposed on cities by the general law of North Carolina. "CHAPTER II. "CORPORATE BOUNDARIES. "Section 2-1. Village Boundaries. Until modified in accordance with the law, the boundaries of the Village of Carolina Trace are as follows: Beginning at an iron stake in the eastern right-of-way line of NC Highway 87 marking the northwest corner of the Carolina Trace Volunteer Fire Department, Inc., fire station lot as shown on a map thereof recorded in Lee County Registry P. C. 6, Slide 136; thence with the eastern line of NC Highway 87 North 12° 47' 39"West 612.68 feet to the southwestern corner of the Carolina Trace Corporation maintenance area; thence with the

succeeding calls of said Outer Boundary Line to the Beginning Point of the Inner Boundary Line of the Buffer Zone.

"CHAPTER III. "GOVERNING BODY.

"Section 3-1. **Structure of the Governing Body; Number of Members.** The governing body of the Village of Carolina Trace is the Board of Commissioners which has four members.

"Section 3-2. **Manner of Electing Board.** The qualified voters of the entire town nominate and elect the Board.

 "Section 3-3. **Term of Office of Board Members.** In 1997, four members shall be elected to the Board. The two members receiving the highest numbers of votes shall serve four-year terms. The two receiving the next highest numbers of votes shall serve two-year terms. In 1999, and quadrennially thereafter, two members shall be elected to the Board. In 2001, and quadrennially thereafter, two members shall be elected to the Board.

"Section 3-4. **Mayor; Term of Office.** The Mayor shall be selected by the Board of Commissioners from among its membership to serve a two-year term ending at the next organizational meeting of the Council.

"CHAPTER IV. "ELECTIONS.

"Section 4-1. **Method.** Board members shall be elected on a nonpartisan plurality basis and the results determined in accordance with G.S. 163-292.

"Section 4-2. **Results.** Election results shall be determined according to Chapter 163 of the General Statutes.

 "Section 4-3. **General Law.** Except as provided by this Charter, town elections shall be conducted in accordance with Chapter 163 of the General Statutes. Elections in even-numbered years shall be conducted by the same method as in odd-numbered years.

"CHAPTER V. "ADMINISTRATION.

"Section 5-1. **Mayor-Council Plan.** The Village of Carolina Trace shall operate under the Mayor-Council Plan as provided in Part 3 of Article 7 of Chapter 160A of the General Statutes.

"Section 5-2. **Interim Board.** From the effective date of this Charter until the organizational meeting of the Board of Commissioners after the 1997 municipal elections, the Board of Commissioners consists of six members and the members of the Board shall be: Joseph F. Kilmartin, Ben Kline, Lee Dodge, Richard Bill, Leo Smith, and Bob Downing. From the effective date of this Charter until the organizational meeting of the Board of Commissioners after the 1997 municipal elections, the mayor is Richard McNamara.

Section 2. (a) From and after the effective date of this act, the citizens and property in the Village of Carolina Trace shall be subject to municipal taxes levied for the year beginning July 1, 1997, and for that purpose the Village shall obtain from the county where the property is located a record of property in the area herein incorporated which

was listed for taxes as of January 1, 1997; and the businesses in the Village shall be liable for privilege license tax from the effective date of the privilege license tax ordinance.

If the effective date of this act is before July 1, 1997, the Village may adopt a budget ordinance for fiscal year 1996-97 without following the timetable in the Local Government Budget and Fiscal Control Act, but shall follow the sequence of actions in the spirit of the act insofar as is practical. The Village may adopt a budget ordinance for fiscal year 1997-98 without following the timetable in the Local Government Budget and Fiscal Control Act, but shall follow the sequence of actions in the spirit of the act insofar as is practical. For fiscal year 1997-98, ad valorem taxes may be paid at par or face amount within 90 days of adoption of the budget ordinance, and thereafter in accordance with the schedule in G.S. 105-360 as if the taxes had been due
