11	The General Assembly of North Carolina enacts:
12	Section 1. Section 11A.127 of S.L. 1997-443 reads as rewritten:
13	"Section 11A.127. Pending the results of action by the General Assembly on the
14	recommendations of the Environmental Review Commission resulting from the study to
15	be undertaken by the Environmental Review Commission as provided in this Part, on-site
16	wastewater functions, public drinking water programs, and environmental health
17	programs shall remain in the Department of Environment and Natural Resources, the
18	Division of Environmental Health, shall remain intact in the Department of Environment
19	and Natural Resources, and the Department of Environment and Natural Resources shall

1	not consolidate on-site wastewater functions or drinking water programs in the Division

3	Section 2. Section 11A.128 of S.L. 1997-443 reads as rewritten:		
4	"Section 11A.128. The Environmental Review Commission shall study the following		
5	issues and report its findings to the 1997 General Assembly, Regular Session 1998, 1999		
6	General Assembly, along with any legislation it proposes to address these issues:		
7	(1)	The appropriate roles and financing of local and state agencies in	
8		reviewing, permitting, inspecting, and monitoring private wells,	
9		community wells, municipal wells, and municipal surface water

Section 3. Section 11A.129 of S.L. 1997-443 reads as rewritten:

"Section 11A.129. The Secretary of Health and Human Services may reorganize the
Department of Health and Human Services in accordance with G.S. 143B-10 and shall
report as required by that section. In addition, the Department of Health and Human
Services shall do the following:

- 6 (1) Report to the Joint Legislative Commission on Governmental
  7 Operations by December 31, 1997, on the Department's progress in incorporating health functions and agencies into the Department;
- 9 (2) Report to the General Assembly by May 1, 1998, <u>1 February 1999</u> on 10 additional changes, including proposed legislation necessary to 11 effectuate the purposes of this Part including the findings of the 12 Environmental Review Commission's study.
- 13 (3) Report to the Joint Legislative Commission on Governmental
  14 Operations by October 31, 1998, 1 February 1999 on any proposed
  15 changes in the Department's structure of boards and commissions not
  16 already implemented as a result of the Environmental Review
  17 Commission's study or necessary to effectuate the purposes of this Part
  18 and to deliver services more efficiently;
- 19(4)Report to the General Assembly by February 1, 1999, on the20Department's progress in adopting any rule changes necessary to21effectuate the purposes of this Part and any proposed legislation22necessary to change the structure of any boards and commissions as23reported to the Joint Legislative Commission on Governmental24Operations."
  - Section 4. This act is effective when it becomes law.
