A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS FOR ADULT DEVELOPMENTAL VOCATIONAL PROGRAMS, AS RECOMMENDED BY THE TASK FORCE TO DETERMINE THE MINIMUM REIMBURSEMENT RATE FOR ADULT DEVELOPMENTAL ACTIVITY PROGRAMS.

The General Assembly of North Carolina enacts:

- Section 1. (a) There is appropriated from the General Fund to the Department of Human Resources, Division of Mental Health, Developmental Disabilities, and Substance Abuse Services, the sum of six million seven hundred twenty-eight thousand five hundred eight dollars (\$6,728,508) for the 1997-98 fiscal year to expand current funding for Adult Developmental Vocational Programs (ADVP) to meet recommended minimum reimbursement formula percentages as provided under subsection (b) of this section.
- (b) Based on the unit cost reimbursement methodology, the Division shall increase minimum levels of reimbursement to Adult Developmental Vocational Programs according to the following formula:
  - (1) Adult Developmental Vocational Programming shall be increased to eighty-five percent (85%) of actual costs;
  - (2) Individual Supported Employment shall be increased to one hundred percent (100%) of actual costs; and
