11	The General	Assembly finds:
12	<u>(1)</u>	Roller skating is a sport that is enjoyed on a regular basis by thousands
13		of North Carolina families. It is an affordable sport and a form of
14		exercise for young and old alike.
15	<u>(2)</u>	The stable and efficient operation of roller skating rinks is essential in
16		order to provide a safe and supervised area for roller skaters to practice
17		their sport.
18	<u>(3)</u>	Liability insurance for roller skating rink operators is difficult to find
19		and expensive to maintain.
