1 2 AN ACT TO AMEND THE LOBBYING LAW. 3 The General Assembly of North Carolina enacts:

Section 1. G.S. 120-47.6(d) reads as rewritten:

When a lobbyist fails to file a lobbying expense report as required herein, the 5 "(d) Secretary of State shall send a certified or registered letter advising the lobbyist of the 6 delinquency and the penalties provided by law. Within 20 days of the receipt of the letter, 7 the lobbyist shall deliver or post by United States mail to the Secretary of State the 8 9 required report and an additional late filing fee of ten dollars (\$10.00). fifty dollars 10 (\$50.00) per day for each day the report is late, not to exceed one thousand dollars (\$1,000). The Secretary of State may reduce or waive a late filing fee under this section 11 for excusable neglect, unavoidable delay, or other good cause. 12 Filing of the required report and payment of the additional fee within the time 13

extended shall constitute compliance with this section. Failure to file an expense report in 14 one of the manners prescribed herein shall result in revocation of any and all registrations 15 of a lobbyist under this Article. No lobbyist may register or reregister under this Article 16 until he has fully complied with this section." 17 18

1	"(d) When a lobbyist's principal fails to file a lobbying expense report as required
2	herein, the Secretary of State shall send a certified or registered letter advising the

4	of the receipt of the letter, the lobbyist's principal shall deliver or post by United States
5	mail to the Secretary of State the required report and a late filing fee of ten dollars
6	(\$10.00) fifty dollars (\$50.00) per day for each day the report is late, not to exceed one
7	thousand dollars (\$1,000). The Secretary of State may reduce or waive a late filing fee
8	under this section for excusable neglect, unavoidable delay, or other good cause.
9	Filing of the required report and payment of the late fee within the time extended shall
10	constitute compliance with this section."
11	Section 3. G.S. 120-47.9 reads as rewritten:
12	"§ 120-47.9. Punishment for violation.

13 Whoever willfully violates any provision of this Article shall be guilty of a Class 1-A1

- 14 misdemeanor. In addition, no lobbyist who is convicted of a violation of the provisions 15 of this Article shall in any way act as a lobbyist for a period of two years following his
- 16 conviction."
