2	AN ACT TO MAKE POSSESSION OF VIDEO POKER AND OTHER VIDEO GAME
3	MACHINES IN NORTH CAROLINA UNLAWFUL.
4	The General Assembly of North Carolina enacts:
5	Section 1. Chapter 14 of the General Statutes is amended by adding a new
6	section to read:
7	" <u>§ 14-306.1. Types of machines and devices prohibited by law; penalties.</u>
8	(a) Notwithstanding G.S. 14-306, it shall be unlawful for any person to keep on
9	that person's premises or to operate or permit to be kept on that person's premises any
10	video game machine on which any of the following games are played by depositing a
11	coin, credit card, or debit card, or by any other means which would effectuate payment to
12	activate the game:
13	(1) <u>A video poker game or any other kind of video card game.</u>
14	(2) <u>A video bingo game.</u>
15	(3) <u>A video craps game.</u>
16	(4) <u>A video keno game.</u>
17	(5) <u>A video lotto game.</u>

1	(6) A video game that involves matching different pictures, words,
2	<u>numbers, or symbols.</u>
3	This section shall not apply to assemblers, manufacturers, and transporters of the
4	prohibited machines and devices who assemble, manufacture, and transport them for sale
5	in another state as long as the machines, while located in this state, cannot be used to play
6	the prohibited games.
7	(b) Any person violating the provisions of this section is guilty of a Class 1
8	misdemeanor and, upon conviction, shall be fined not less than one thousand dollars
9	<u>(\$1,000).</u>
10	A second or subsequent violation of this section is a Class I felony.
11	A person violating the provisions of this section involving the operation or having
12	caused the operation of 10 or more machines prohibited by this section shall be guilty of
13	<u>a Class G felony.</u>
14	This section does not make unlawful or against public policy anything which on July
15	1, 2000 was lawful for any federally recognized Indian Tribe under the Indian Gaming
16	Regulatory Act."
17	Section 2. G.S. 14-298 reads as rewritten:
18	"§ 14-298. Gaming tables, illegal punchboards and slot machines to be destroyed by
19	police officers.
20	All sheriffs and officers of police are hereby authorized and directed, on information
21	made to them on oath that any gaming table prohibited to be used by G.S. 14-289 through
22	14-300, or-any illegal punchboard or illegal slot machine-machine, or any video game
23	machine prohibited to be used by G.S. 14-306.1, is in the possession or use of any person
24	within the limits of their jurisdiction, to destroy the same by every means in their power;
25	and they shall call to their aid all the good citizens of the county, if necessary, to effect its
26	destruction."
27	Section 3. This act becomes effective December 1, 2000.
