- (5) "Computer software" means a set of computer programs, procedures and 1 2 associated documentation concerned with the operation of a computer, 3 computer system, or computer network. 4 "Computer system"means at least one computer together with a set of (6) 5 related, connected, or unconnected peripheral devices. 6 (6a) "Data"means a representation of information, facts, knowledge, 7 concepts, or instructions prepared in a formalized or other manner and 8 intended for use in a computer, computer system, or computer network. 9 Data may be embodied in any form including, but not limited to, 10 computer printouts, magnetic storage media, and punch cards, or may be stored internally in the memory of a computer. 11 12 "Electronic mail service provider"means any person who (i) is an (6b) intermediary in sending or receiving electronic mail and (ii) provides to 13 14 end-users of electronic mail services the ability to send or receive 15 electronic mail. "Financial instrument"includes any check, draft, money order, 16 **(7)** 17 certificate of deposit, letter of credit, bill of exchange, credit card or 18 marketable security, or any electronic data processing representation thereof 19 20 "Property"includes (8) financial instruments. information, 21 electronically processed or produced data, and computer software and computer programs in either machine or human readable form, and any 22 other tangible or intangible item of value. 23 24 "Resource"includes peripheral devices, computer software, computer (8a) programs, and data, and means to be a part of a computer, computer 25 system, or computer network. 26 (9) "Services"includes computer time, data processing and storage 27 functions 28 29 "Spam"includes unsolicited bulk commercial electronic mail, sent by a (10)30 person using a computer, computer network, or the computer services of an electronic mail service provider in contravention of the authority 31 granted by or in violation of the policies set by the electronic mail 32 service provider. Transmission of commercial electronic mail from an 33 organization to its members shall not be deemed to be unsolicited bulk 34 35 commercial electronic mail. "Unsolicited"means not addressed to a recipient with whom the initiator 36 (11)has an existing business or personal relationship and not sent at the 37 38 request of, or with the express consent of, the recipient."
 - Section 3. Article 60 of Chapter 14 of the General Statues is amended by adding a new section to read:

"§ 14-458. Computer trespass; penalty; damages.

(a) It shall be unlawful for any person to use a computer or computer network without authority and with the intent to do any of the following:

- (1) Temporarily or permanently remove, halt, or otherwise disable any computer data, computer programs, or computer software from a computer or computer network.
 - (2) Cause a computer to malfunction, regardless of how long the malfunction persists.
 - (3) Alter or erase any computer data, computer programs, or computer software.
 - (4) Cause physical injury to the property of another.
 - Make or cause to be made an unauthorized copy, in any form, including, but not limited to, any printed or electronic form of computer data, computer programs, or computer software residing in, communicated by, or produced by a computer or computer network.
 - (6) Falsely identify or forge commercial electronic mail transmission information or other routing information in any manner in connection with the transmission of unsolicited bulk commercial electronic mail through or into the computer network of an electronic mail service provider or its subscribers.

For purposes of this subsection, a person is "without authority" when (i) the person has no right or permission of the owner to use a computer, or the person uses a computer in a manner exceeding the right or permission or (ii) the person uses a computer or computer network, or the computer services of an electronic mail service provider to transmit unsolicited bulk commercial electronic mail in contravention of the authority granted by or in violation of the policies set by the electronic mail service provider.

- (b) Any person who violates this section shall be guilty of computer trespass, which offense shall be punishable as a Class 3 misdemeanor. If there is damage to the property of another, and the damage is valued at less than two thousand five hundred dollars (\$2,500) caused by the person's act in violation of this section, the offense shall be punished as a Class 1 misdemeanor. If there is damage to the property of another valued at two thousand five hundred dollars (\$2,500) or more, caused by the person's act in violation of this section, the offense shall be punished as a Class G felony.
- (c) Any person whose property or person is injured by reason of a violation of this section may sue for and recover for any damages sustained and the costs of the suit. Without limiting the general of the term, "damages"shall include loss of profits. If the injury arises from the transmission of unsolicited bulk commercial electronic mail, the injured person, other than an electronic mail service provider, may also recover attorneys' fees, and may elect, in lieu of actual damages, to recover the lesser of ten dollars (\$10.00) for each and every unsolicited bulk commercial electronic mail message transmitted in violation of this section, or twenty-five thousand dollars (\$25,000) per day. The injured person shall not have a cause of action against the electronic mail service provider which merely transmits the unsolicited bulk commercial electronic mail over its computer network. If the injury arises from the transmission of unsolicited bulk commercial electronic mail, an injured electronic mail service provider may also recover attorneys' fees and costs, and may elect, in lieu of actual damages, to recover the greater of ten

dollars (\$10.00) for each and every unsolicited bulk commercial electronic mail message transmitted in violation of this section, or twenty-five thousand dollars (\$25,000) per day.

3 4 5 (d) A civil action under this section shall be commenced before expiration of the time period prescribed in G.S. 1-54. In actions alleging injury arising from the transmission of unsolicited bulk commercial electronic mail, personal jurisdiction may be exercised pursuant to G.S. 1-75.4(13)."

Section 4. This act becomes effective October 1, 1999. Section 3 of the act applies to offenses occurring on or after October 1, 1999.
