4	Whereas, North Carolina is known throughout the world for its pottery
5	traditions, literary legacy, Southern Appalachian music traditions, jazz, blues and gospel
6	heritage, and an abundance of artists and arts institutions; and
7	Whereas, North Carolina's arts community is strong and vibrant and it
8	contributes greatly to the rich quality of life and to the healthy economy that this State
9	enjoys; and
10	Whereas, the North Carolina Arts Council has worked to build a community
11	of artists and arts organizations so that all of our citizens and visitors to our State will
12	have the opportunity to enjoy the arts; and
13	Whereas, in 2003, the national average for per capita spending by state arts
14	councils will be \$1.50; and
15	Whereas, an additional \$6,000,000 appropriation added to the North Carolina
16	Arts Council's recurring appropriation would allow North Carolina to reach the national
17	average; and
18	Whereas, in each of the years during the 1999-2001 biennium, the North
19	Carolina Arts Council received a nonrecurring appropriation of \$2,000,000; and
20	Whereas, there is precedent in North Carolina's budgeting process for such an
21	appropriation to become part of the recurring budget in the third year; Now, therefore,

There is appropriated from the General Fund to the 1 SECTION 1. Department of Cultural Resources, Division of Arts Council, the sum of two million 2 dollars (\$2,000,000) for the 2001-2002 fiscal year and the sum of four million dollars 3 (\$4,000,000) for the 2002-2003 fiscal year to support the programs of the North 4 Carolina Arts Council. These funds shall be in addition to appropriations already in the 5 6 base budget for the North Carolina Arts Council and shall become part of the North 7 Carolina Arts Council's continuation budget. SECTION 2. This act becomes effective July 1, 2001. 8
