1	A BILL TO BE ENTITLED
2	AN ACT TO AMEND THE LAW PERTAINING TO THE SCHOOL HEALTH
3	CURRICULUM.
4	The General Assembly of North Carolina enacts:
5	<b>SECTION 1.</b> G.S. 115C-81(e1) reads as rewritten:
6	"(e1) School Health Education Program to Be Developed and Administered.
7	(1) A comprehensive school health education program shall be developed
8	and taught to pupils of the public schools of this State from
9	kindergarten through ninth grade. This program includes
10	age-appropriate instruction in the following subject areas, regardless of
11	whether this instruction is described as, or incorporated into a
12	description of, "family life education", "family health education",
13	"health education", "family living", "health", "healthful living
14	curriculum", or "self-esteem":
15	a. Mental and emotional health;
16	b. Drug and alcohol abuse prevention;
17	c. Nutrition;
18	d. Dental health;
19	e. Environmental health;
20	f. Family living;
21	g. Consumer health;
22	h. Disease control;
23	i. Growth and development;
24	j. First aid and emergency care, including the teaching of
25	cardiopulmonary resuscitation (CPR) and the Heimlich
26	maneuver by using hands-on training with mannequins so that
27	students become proficient in order to pass a test approved by

the American Heart Association, or American Red Cross;

- k. Preventing sexually transmitted diseases, including Acquired Immune Deficiency Syndrome (AIDS) virus infection, and other communicable diseases;
- 1. Abstinence until marriage education; and
- m. Bicycle safety: and
- n. Any other age appropriate health education curriculum approved by a local school administrative unit.

A comprehensive school health education program includes any offcampus component that is part of the curriculum of instruction. A comprehensive school health education program does not include individual consultation or counseling outside of the curriculum of instruction.

- The State Board of Education shall supervise the development and (2) operation of a statewide comprehensive school health education program including curriculum development, in-service training provision and promotion of collegiate training, learning material review, and assessment and evaluation of local programs in the same manner as for other programs. The State Board of Education shall adopt objectives for the instruction of the subject areas listed in subdivision (1) of this subsection that are appropriate for each grade level. In addition, the State Board shall approve textbooks and other objectives incorporating these that materials administrative units may purchase with State funds. The State Board of Education, through the Department of Public Instruction, shall, on a regular basis, review materials related to these objectives, and distribute these reviews to local school administrative units for their information.
- The State Board of Education shall develop objectives for instruction (3) in the prevention of sexually transmitted diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS) virus infection, that includes emphasis on the importance of parental involvement, abstinence from sex until marriage, and avoiding intravenous drug use. Any program developed under this subdivision shall present techniques and strategies to deal with peer pressure and to offer positive reinforcement and shall teach reasons, skills, and strategies for remaining or becoming abstinent from sexual activity; for appropriate grade levels and classes, shall teach that abstinence from sexual activity until marriage is the only certain means of out-of-wedlock pregnancy, pregnancy and sexually avoiding transmitted diseases, and other associated health and emotional problems, and that a mutually faithful monogamous heterosexual relationship in the context of marriage is the best lifelong means of avoiding diseases transmitted by sexual contact, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS); and

- shall teach the positive benefits of abstinence until marriage and the risks of premarital sexual activity. Any instruction concerning the causes of sexually transmitted diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS), in cases where homosexual and heterosexual acts are a significant means of transmission, shall include the current legal status of those acts.
- (4) The State Board of Education shall evaluate abstinence until marriage curricula and their learning materials and shall develop and maintain a recommended list of one or more approved abstinence until marriage curricula. The State Board may develop an abstinence until marriage program curriculum to include on the recommended list. The State Board of Education shall not select or develop a program curriculum for inclusion on the recommended list that does not include the positive benefits of abstinence until marriage and the risks of premarital sexual activity as the primary focus. The State Board shall include on the recommended list only programs curricula that include, in appropriate grades and classes, instruction that:
  - a. Teaches that abstinence from sexual activity outside of marriage is the expected standard for all school-age children;
  - b. Presents techniques and strategies to deal with peer pressure and offering positive reinforcement;
  - c. Presents reasons, skills, and strategies for remaining or becoming abstinent from sexual activity;
  - d. Teaches that abstinence from sexual activity is the only certain means of avoiding out-of-wedlock pregnancy, sexually transmitted diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS), and other associated health and emotional problems;
  - e. Teaches that a mutually faithful monogamous heterosexual relationship in the context of marriage is the best lifelong means of avoiding sexually transmitted diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS);
  - f. Teaches the positive benefits of abstinence until marriage and the risks of premarital sexual activity;
  - g. Provides opportunities that allow for interaction between the parent or legal guardian and the student; and
  - h. Provides factually accurate biological or pathological information that is related to the human reproductive system. 'Factually accurate biological or pathological information' means information supported by research recognized as accurate and objective by leading medical, psychological, and public health organizations and agencies, and where relevant, tested in clinical trials and published in peer review journals.

- (5) The State Board of Education shall make available to all local school administrative units for review by the parents and legal guardians of students enrolled at that unit any State-developed objectives for instruction, any approved textbooks, the list of reviewed materials, and any other State-developed or approved materials that pertain to or are intended to impart information or promote discussion or understanding in regard to the prevention of sexually transmitted diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS), to the avoidance of out-of-wedlock pregnancy, or to the abstinence until marriage curriculum. The review period shall extend for at least 60 days before use.
- (6) Each local school administrative unit shall provide a comprehensive school health education program curriculum for kindergarten through ninth grade that meets all the requirements of this subsection and all the objectives established by the State Board. Each local board of education may expand on the subject areas to be included in the program and on the instructional objectives to be met. This expanded program may include a comprehensive sex education program for that local school administrative unit curriculum addressing reproductive health only if all of the following requirements are satisfied:
  - a. Before a comprehensive sex education program an expanded curriculum is adopted, the local board of education shall conduct a public hearing, after adequately notifying the public of the hearing.
  - b. For at least 30 days before this public hearing and during this public hearing, the objectives for this proposed program expanded curriculum and all instructional materials shall be made available for review.
  - c. For at least 30 days after the public hearing, the objectives for the <u>program expanded curriculum</u> and all instructional materials shall remain available for review by parents and legal guardians of students in that local school administrative unit.
- (7) Each school year, before students may participate in any portion of a health education curriculum that pertains to (i) a program that pertains to or is intended to impart information or promote discussion or understanding in regard to the prevention of sexually transmitted diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS), or to the avoidance of out-of-wedlock pregnancy, (ii) an abstinence until marriage program, marriage, or (iii) a comprehensive sex education program, a curriculum that is expanded beyond a comprehensive school education program, whether developed by the State or by the local board of education, the parents and legal guardians of those students shall be given an opportunity to review the objectives and materials. Local boards of education shall

Students may receive The health education curriculum may provide for 5 (8) the dissemination of information about where to obtain contraceptives 6 7 and abortion referral services only in accordance with a local board's 8 policy regarding parental consent. Any instruction within the 9 curriculum concerning the use of contraceptives or prophylactics shall provide accurate statistical information on their effectiveness and 10 failure rates for preventing pregnancy and sexually transmitted 11 12 diseases, including the sexual transmission of Acquired Immune Deficiency Syndrome (AIDS), in actual use among adolescent 13 14 populations and shall explain clearly the difference between risk reduction and risk elimination through abstinence.(AIDS). 15 Contraceptives, including condoms and other devices, shall not be 16 (9) 17 made available or distributed on school property. School health coordinators may be employed to assist in the 18 (10)instruction of any portion of the comprehensive school health 19 20 education program. Where feasible, a school health coordinator should 21 serve more than one local school administrative unit. Each person 22 initially employed as a State-funded school health coordinator after
  - **SECTION 2.** This act is effective when it becomes law and applies beginning with the 2001-2002 school year.
