A BILL TO BE ENTITLED

AN ACT TO CONVERT THREE TEMPORARY AVIATION POSITIONS WITHIN
THE DIVISION OF FOREST RESOURCES OF THE DEPARTMENT OF
ENVIRONMENT AND NATURAL RESOURCES TO PERMANENT
POSITIONS AND TO APPROPRIATE FUNDS TO IMPLEMENT THIS
CONVERSION.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.** The two temporary pilot positions within the Division of 9 Forest Resources of the Department of Environment and Natural Resources are 10 converted to permanent positions.

SECTION 2.(a) There is appropriated from the General Fund to the Division of Forest Resources, Department of Environment and Natural Resources, the sum of thirty-seven thousand four hundred seventy-four dollars (\$37,474) for the 2001-2002 fiscal year and the sum of thirty-seven thousand four hundred seventy-four dollars (\$37,474) for the 2002-2003 fiscal year to establish and support the permanent positions under Section 1 of this act.

SECTION 2.(b) The sum needed to establish and support the pilot positions as permanent positions equals eighty-nine thousand four hundred seventy-four dollars (\$89,474) for each the 2001-2002 fiscal year and the 2002-2003 fiscal year. The sum needed to continue and support the pilot positions as temporary positions equals fifty-two thousand dollars (\$52,000) for each the 2001-2002 fiscal year and the 2002-2003 fiscal year. The funds appropriated under subsection (a) of this section represent the difference between these two sums.

SECTION 3. The temporary position of aircraft mechanic within the Division of Forest Resources of the Department of Environment and Natural Resources is converted to a permanent position.

27 **SECTION 4.(a)** There is appropriated from the General Fund to the 28 Division of Forest Resources, Department of Environment and Natural Resources, the

sum of twenty-one thousand three hundred ninety-three dollars (\$21,393) for the 1 2 2001-2002 fiscal year and the sum of twenty-one thousand three hundred ninety-three 3 dollars (\$21,393) for the 2002-2003 fiscal year to establish and support the permanent 4 position under Section 3 of this act. 5 **SECTION 4.(b)** The sum needed to establish and support the position of 6 aircraft mechanic as a permanent position equals forty-five thousand one hundred five 7 dollars (\$45,105) for each the 2001-2002 fiscal year and the 2002-2003 fiscal year. The 8 sum needed to continue and support the position of aircraft mechanic as a temporary 9 position equals twenty-three thousand seven hundred twelve dollars (\$23,712) for each 10 the 2001-2002 fiscal year and the 2002-2003 fiscal year. The funds appropriated under subsection (a) of this section represent the difference between these two sums. 11 12 **SECTION 5.** This act becomes effective July 1, 2001.
