2 AN ACT TO AUTHORIZE THE CITY OF SALISBURY TO ADOPT AND3 ENFORCE ORDINANCES RELATING TO PARKING.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** Article 2 of Chapter VII of the Charter of the City of 6 Salisbury, as revised and consolidated by S.L. 1987-205, is amended by adding the 7 following new section:

"Sec. 7.4. Parking Regulations and Violations.

9 (a) The City Council may provide by ordinance that each hour a vehicle remains 10 illegally parked in an on-street parking space is a separate offense, and the violator may 11 be given a ticket for each offense.

(b) The City Council may provide by ordinance that any vehicle that has been towed for a parking violation is to be held until the towing fee and penalties related to all outstanding parking tickets and parking penalties owed to the City are paid in full, or a bond is posted in the amount of the towing fee and all outstanding parking tickets and parking penalties. Payment of the towing fee and all outstanding parking tickets and parking penalties shall not constitute a waiver of a person's right to contest the towing or the outstanding parking tickets and parking penalties.

The City Council may provide by ordinance for the use of wheel locks on 19 (c) illegally parked vehicles for which there are three or more outstanding, unpaid, and 20 overdue parking tickets for a period of 90 days. The ordinance shall provide for notice 21 22 or warning to be affixed to the vehicle, immobilization, towing, impoundment, appeal hearing, an immobilization fee not to exceed fifty dollars (\$50.00), and charges for 23 towing and storage. The City shall not be responsible for any damage to an immobilized 24 25 illegally parked vehicle resulting from unauthorized attempts to free or move that vehicle. 26
