A BILL TO BE ENTITLED

1 AN ACT TO CHANGE THE MANNER OF ELECTION OF THE ROCKINGHAM
2 COUNTY BOARD OF EDUCATION.
3

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** Notwithstanding the PLAN FOR MERGER OF THE PUBLIC
6 SCHOOL SYSTEMS IN ROCKINGHAM COUNTY INTO ONE SYSTEM, as
7 approved by the State Board of Education on July 2, 1992, under G.S. 115C-67,
8 effective from the first Monday in December of 2006 until the first Monday in
9 December of 2008, the Rockingham County Consolidated Board of Education consists
10 of 13 members as follows:

- 11 (1) Five elected from the county at large; and
12 (2) Eight elected from districts, one each from a single-member district by
13 the voters of that district. These eight members shall continue to
14 represent the seats elected in 2002 and those elected in 2004. The
15 terms of office of the four members that were to expire on the second
16 Tuesday in December of 2006 are extended until the first Monday in
17 December of 2008. The terms of office of the four members elected in
18 2004 to serve until the second Tuesday in December of 2008 shall
19 instead terminate on the first Monday in December of 2008. If any
20 vacancies occur in any of these seats prior to the first Monday in
21 December of 2008, the Rockingham County Board of Commissioners
22 shall appoint replacements from the same district to serve the
23 remainder of the term.

24 **SECTION 2.** Notwithstanding the PLAN FOR MERGER OF THE PUBLIC
25 SCHOOL SYSTEMS IN ROCKINGHAM COUNTY INTO ONE SYSTEM, as
26 approved by the State Board of Education on July 2, 1992, under G.S. 115C-67,
27 effective from the first Monday in December of 2008, the Rockingham County
28 Consolidated Board of Education consists of 11 members as follows:

- 1 (1) Five elected from the county at large; and
- 2 (2) Six elected from districts, one each from a single-member district by
- 3 the voters of that district. The boundaries of the districts shall be
- 4 determined by Section 5 of this act.

5 **SECTION 3.** The five at-large members shall be elected in 2006 and
6 quadrennially thereafter for four-year terms. The six district members shall be elected in
7 2008 and quadrennially thereafter for four-year terms. In case of any vacancy, the
8 Rockingham County Board of Commissioners shall appoint a replacement to serve the
9 remainder of the unexpired term.

8 **SECTION 5.** Section 2 of Chapter 15 of the 1993 Session Laws reads as
9 rewritten:

10 "Sec. 2. (a) Notwithstanding G.S. ~~163-279(a)(4)~~163-279(a)(1) and Section
11 IV.B. of the PLAN FOR MERGER OF THE PUBLIC SCHOOL SYSTEMS IN
12 ROCKINGHAM COUNTY INTO ONE SYSTEM, as approved by the State Board of
13 Education on July 2, 1992, under G.S. 115C-67, the election of the Rockingham County
14 Consolidated Board of Education shall take place on the Tuesday after the first Monday
15 in November of each year that the PLAN FOR MERGER OF THE PUBLIC SCHOOL
16 SYSTEMS IN ROCKINGHAM COUNTY INTO ONE SYSTEM calls for an election
17 to take place, ~~and the runoff election, if required, shall be on the fourth Tuesday~~
18 ~~thereafter.~~place.

19 (b) Notwithstanding Section IV.D. of the PLAN FOR MERGER OF THE
20 PUBLIC SCHOOL SYSTEMS IN ROCKINGHAM COUNTY INTO ONE SYSTEM,
21 as approved by the State Board of Education on July 2, 1992, under G.S. 115C-67, ~~in~~
22 ~~any year where a runoff election is required for the Rockingham County Consolidated~~
23 ~~Board of Education and the date of the runoff is after the first Monday in December, the~~
24 ~~election shall be decided on a plurality basis under G.S. 163-292, and all the newly~~
25 ~~elected board members shall take office on the second Tuesday~~first Monday
26 in December following their election."

27 **SECTION 6.** The chair of the Rockingham County Consolidated Board of
28 Education shall be elected by the Board from among its members at the organizational
29 meeting after each election to serve until the organizational meeting of the Board after
30 the next election.

31 **SECTION 7.** This act is effective when it becomes law.
