## A BILL TO BE ENTITLED

AN ACT TO ESTABLISH A LEGISLATIVE OVERSIGHT COUNCIL ON CHILD
MALTREATMENT PREVENTION AND AN INTERAGENCY LEADERSHIP
TEAM FOR CHILD MALTREATMENT PREVENTION AND TO
APPROPRIATE FUNDS FOR THAT PURPOSE.

6 The General Assembly of North Carolina enacts:

**SECTION 1.(a)** The Legislative Oversight Council on Child Maltreatment 7 Prevention (Council) and the Interagency Leadership Team for Child Maltreatment 8 Prevention (Leadership Team) are established within the Department of Health and 9 Human Services, Division of Public Health, for the purpose of preventing child 10 maltreatment in North Carolina. The Legislative Oversight Council on Child 11 Maltreatment Prevention is created to ensure implementation of plans recommended by 12 the North Carolina Institute of Medicine Task Force on Child Abuse Prevention and to 13 14 improve communication, accountability, and coordination efforts among the multiple systems working to strengthen families. For purposes of this section, multiple systems 15 shall include services offered by the Division of Public Health, the Division of Mental 16 Health, the Department of Public Instruction, the Division of Social Services, and any 17 other private or nonprofit organizations. The Interagency Leadership Team for Child 18 Maltreatment Prevention is created to support the work of the Legislative Oversight 19 Council on Child Maltreatment Prevention. 20

SECTION 1.(b) The Council shall consist of no more than 15 members. On or after January 1, 2006, the General Assembly, upon recommendation of the President Pro Tempore of the Senate, shall appoint five members, two of whom shall serve two-year terms, and three of whom shall serve one-year terms; the General Assembly, upon recommendation of the Speaker of the House of Representatives, shall appoint five members, three of whom shall serve two-year terms, and two of whom shall serve one-year terms; and the Division of Public Health shall appoint five members, two of

1	whom shall serve two-year terms, and three of whom shall serve two-year terms. Upon		
2	the expiration of the initial Council members, each member shall be appointed for a		
3	term of two years and shall serve until a successor is appointed. Members of the Council		
4	shall include representatives from the various State agencies as well as professional		
5	associations and nonprofit organizations that serve families and children. The		
6	appointing authority shall have the power to remove any member of the Council from		
7	office. Any appointment to fill a vacancy on the Council created by the resignation,		
8	dismissal, death, or disability of a member shall be for the remainder of the unexpired		
9	term. No member may serve more than two consecutive terms.		
10	The Leadership Team shall consist of no more than five members of the		
11	Council appointed by the Division of Public Health for one-year terms.		
12	<b>SECTION 1.(c)</b> Both the Council and the Leadership Team shall continue		
13	the work of the North Carolina Institute of Medicine Task Force on Child Abuse		
14	Prevention (Task Force) by:		
15	(1) Ensuring implementation of the Task Force recommendations.		
16	(2) Identifying, promoting, and finding ways to support evidence-based		
17	child abuse prevention programs.		
18	(3) Strategically coordinating the planning, implementation, and		
19	evaluation of child abuse prevention efforts across multiple systems as		
20	described in subsection (a) of this section.		
21	(4) Requiring collaboration among the multiple systems to better use		
22	existing funds for evidence-based and research-based initiatives.		
23	<b>SECTION 1.(d)</b> The Department of Health and Human Services, Division		
24	of Public Health, shall prepare and submit a report on the Council and Leadership		
25	Team's prevention efforts to the General Assembly no later than December 1 of each		
26	year that shall include the following:		
27	(1) A description of the Council and Leadership Team and the services		
28	each provides.		
29	(2) The quantity of services provided.		
30	(3) A description of any child abuse prevention efforts implemented.		
31	(4) Any recommendations for legislative action.		
32	<b>SECTION 1.(e)</b> The Department of Health and Human Services, Division of		
33	Public Health, may adopt rules to implement this section.		
34	SECTION 2. There is appropriated from the General Fund to the		
35	Department of Health and Human Service, Division of Public Health, the sum of two		
36	hundred fifty thousand dollars (\$250,000) for the 2005-2006 fiscal year for staffing and		
37	operational support in establishing the Legislative Oversight Council on Child		
38	Maltreatment Prevention and the Interagency Leadership Team for Child Maltreatment		
39	Prevention.		
40	<b>SECTION 3.</b> This act becomes effective July 1, 2005.
