3 DISTRICT ATTORNEYS FOR PROSECUTORIAL DISTRICT 29B AND TWO
4 VICTIM WITNESS ASSISTANT POSITIONS FOR PROSECUTORIAL
5 DISTRICT 29B.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.** Effective January 1, 2007, G.S. 7A-60(a1) reads as rewritten:

8 "(a1) The counties of the State are organized into prosecutorial districts, and each
9 district has the counties and the number of full-time assistant district attorneys set forth
10 in the following table:

SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of eighty-nine thousand six hundred eight dollars (\$89,608) for the 2006-2007 fiscal year to establish the two additional assistant district attorney positions authorized by this act.

SECTION 3. There is appropriated from the General Fund to the Judicial Department the sum of forty-eight thousand three hundred fifty-four dollars (\$48,354)

1 for the 2006-2007 fiscal year to establish two additional victim witness assistant
2 positions for Prosecutorial District 29B.

3 **SECTION 4.** This act becomes effective January 1, 2007.
