A BILL TO BE ENTITLED 1 2 FROM AN ACT REMOVING CERTAIN DESCRIBED PROPERTY THE 3 CORPORATE LIMITS OF THE TOWN OF WALKERTOWN. 4 The General Assembly of North Carolina enacts: 5 SECTION 1. The following described property is removed from the corporate limits of the Town of Walkertown: 6 **TRACT I** (Nancy Wooten property): All of that certain tract or parcel of land lying and 7 8 being in Walkertown, Forsyth County, North Carolina, more particularly described as follows: BEGINNING at an existing iron pipe lying in the eastern boundary line of 9 Kathleen Yokley (Deed Book 1238, Page 1456), said iron being the northwest corner of 10 property deeded unto Johnny L. Waddell in Deed Book 1617, Page 1279, Forsyth 11 County Registry; thence from said iron pipe, with the eastern line of Kathleen Yokley, 12 North 04 degrees 04 minutes 23 seconds East 657.68 feet to a bent iron at the base of a 13 14 blown down hickory tree; thence from said iron North 89 degrees 31 minutes 28 seconds East 206.29 feet to a stone; thence North 02 degrees 45 minutes 11 seconds 15 East 181.86 feet to an existing iron pipe; thence with a new line South 81 degrees 44 16 minutes 19 seconds East 451.09 feet to a new iron pipe lying in the western boundary 17 line of property deeded unto Allie Peddycord in Deed Book 556, Page 458, Forsyth 18 County Registry; thence with the western boundary line of Allie Peddycord South 03 19 degrees 37 minutes 46 seconds West 891.00 feet to an old existing iron pipe; thence 20 continuing with the western boundary of Allie Peddycord South 03 degrees 37 minutes 21 22 46 seconds West 298.86 feet to a planted stone, said stone being the southwestern corner of property deeded unto Allie Peddycord in Deed Book 556, Page 458, Forsyth 23 County Registry; thence from said stone with the northern boundary line of property 24 deeded unto Peddycord, Inc. in Deed Book 1361, Page 1119, Forsyth County Registry 25 South 54 degrees 46 minutes 13 seconds West 66.89 feet to an existing iron pipe, the 26 easternmost corner of property deeded unto Theresa Freibott in Deed Book 1541, Page 27

2 75 degrees 20 minutes 10 seconds West 119.52 feet to an existing iron pipe, the 3 southeast corner of property deeded unto Johnny L. Waddell in Deed Book 1617, Page 4 1279, Forsyth County Registry; thence with the eastern line of Johnny L. Waddell North 5 23 degrees 58 minutes 26 seconds West 507.38 feet to an existing iron pipe, the 6 northeast corner of Johnny L. Waddell; thence with the northern line of Johnny L. 7 Waddell North 85 degrees 57 minutes 22 seconds West 259.80 feet to an existing iron 8 pipe, the point and place of BEGINNING, containing 15 acres, more or less, according 9 to an unrecorded map and survey by Larry L. Callahan, R.L.S., dated December 20, 10 1990, and being designated as Tax Block 5400, Lot 11 M. **TRACT II** (L. Paige Wooten property): All of that certain tract or parcel of land lying 11 12 and being in Walkertown, Forsyth County, North Carolina, more particularly described 13 as follows: 14 BEGINNING at a new iron pipe in the line with Allie Peddycord (Deed Book 556, Page 15 548) at a corner with Nancy L. Wooten (Deed Book 1835, Page 4792) and thence South 16 03 degrees 27 minutes 07 seconds West 529.58 feet through an existing iron pipe and 17 continuing on to a second existing iron pipe; thence North 86 degrees 32 minutes 57 18 seconds West 180.00 feet to a new iron pipe in the line with Wooten; thence North 08 19 degrees 50 minutes 34 seconds' East 388.21 feet to an existing iron pipe; thence North 20 48 degrees 32 minutes 14 seconds East 202.67 feet to the point and place of 21 BEGINNING, being 1.67 acres more or less according to a survey by Larry L. TRACT III (Jesse Grimm property): All of that certain tract or parcel of land lying and 25 26 being in Walkertown, Forsyth County, North Carolina, more particularly described as 27 follows: 28 BEGINNING at a point in the centerline of an old creek bed, said point being the 29 southwest corner of Lot Number 3, as shown on the plat of Winchester, Section Two, as 30 recorded in Plat Book 27, Page 142, in the Office of the Register of Deeds of Forsyth 31 County, North Carolina; thence with southern property line of Lots 3 and 4, Winchester, 32 Section Two, as defined by said creek bed the following six (6) courses and distances: 33 (1) South 68 degrees 09 minutes 12 seconds East 91.33 feet to an iron; (2) thence South 34 83 degrees 30 minutes 00 seconds East 129.78 feet to an iron; (3) thence North 60 degrees 24 minutes 27 seconds East 38.78 feet to an iron; (4) thence South 73 degrees 35 54 minutes 09 seconds East 38.26 feet to an iron; (5) thence North 56 degrees 53 36 37 minutes 37 seconds East 26.98 feet to an iron; (6) thence North 85 degrees 47 minutes 38 03 seconds East 155.00 feet to an existing 80D nail in the western line of property now 39 or formerly owned by Allie Peddycord (see Deed Book 556, Page 458, Forsyth County 40 Registry); thence with Peddycord's western line South 03 degrees 27 minutes 04 seconds West 728.26 feet to an iron; thence North 81 degrees 44 minutes 19 seconds 41 42 West 451.09 feet to an iron in the eastern line of property now or formerly owned by Kathleen Yokely (see Deed Book 1238, Page 1456, Forsyth County Registry); thence 43 44 with Yokely's eastern line North 02 degrees 45 minutes 11 seconds East 1005.69 feet to
