HOUSE JOINT RESOLUTION 2071

1 A JOINT RESOLUTION SETTING THE TIME FOR ADJOURNMENT OF THE
2 2007 GENERAL ASSEMBLY TO MEET IN 2008 AND LIMITING THE
3 SUBJECTS THAT MAY BE CONSIDERED IN THAT SESSION.

4 Be it resolved by the House of Representatives, the Senate concurring:

5 **SECTION 1.** When the Senate and the House of Representatives adjourn on
6 Thursday, August 2, 2007, they stand adjourned to reconvene on Tuesday, May 13,
7 2008, at 12:00 noon.

8 **SECTION 2.** During the regular session that reconvenes on Tuesday, May
9 13, 2008, only the following matters may be considered:

10 (1) Bills directly and primarily affecting the State budget, including the
11 budget of an occupational licensing board, for fiscal year 2008-2009,
12 provided that the bill must be submitted to the Bill Drafting Division
13 of the Legislative Services Office no later than 4:00 P.M. Friday, May
14 16, 2008, and must be introduced in the House of Representatives or
15 filed for introduction in the Senate no later than 4:00 P.M. Tuesday,
16 May 27, 2008.

17 (2) Bills and resolutions introduced in 2007 and having passed third
18 reading in 2007 in the house in which introduced, received in the other
19 house in accordance with Senate Rule 41 or House Rule 31.1(d) as
20 appropriate, and not disposed of in the other house by tabling,
21 unfavorable committee report, indefinite postponement, or failure to
22 pass any reading, and which do not violate the rules of the receiving
23 house.

24 (3) Bills and resolutions implementing the recommendations of:
25 a. Study commissions, authorities, and statutory commissions
26 authorized or directed to report to the 2008 Session;
27 b. The General Statutes Commission, the Courts Commission, or
28 any commission created under Chapter 120 of the General
29 Statutes that is authorized or directed to report to the General
30 Assembly;

- 1 c. The House Ethics Committee;
2 d. Select committees; or
3 e. The Joint Legislative Ethics Committee or its Advisory
4 Subcommittee.

5 A bill authorized by this subdivision must be submitted to the Bill
6 Drafting Division of the Legislative Services Office no later than 4:00
7 P.M. Wednesday, May 14, 2008, and must be filed for introduction in
8 the Senate or introduced in the House of Representatives no later than
9 4:00 P.M. Wednesday, May 21, 2008.

10 (4) Any local bill that has been submitted to the Bill Drafting Division of
11 the Legislative Services Office by 4:00 P.M. Wednesday, May 21,
12 2008, is introduced in the House of Representatives or filed for
13 introduction in the Senate by 4:00 P.M. Wednesday, May 28, 2008,
14 and is accompanied by a certificate signed by the principal sponsor
15 stating that no public hearing will be required or asked for by a
16 member on the bill, the bill is noncontroversial, and that the bill is
17 approved for introduction by each member of the House of
18 Representatives and Senate whose district includes the area to which
19 the bill applies.

20 (5) Selection, appointment, or confirmation of members of State boards
21 and commissions as required by law, including the filling of vacancies
22 of positions for which the appointees were elected by the General
23 Assembly upon recommendation of the Speaker of the House of
24 Representatives, President of the Senate, or President Pro Tempore of
25 the Senate.

26 (6) Any matter authorized by joint resolution passed during the 2008
27 Regular Session by a two-thirds majority of the members of the House
28 of Representatives present and voting and by a two-thirds majority of
29 the members of the Senate present and voting. A bill or resolution filed
30 in either house under the provisions of this subdivision shall have a
31 copy of the ratified enabling resolution attached to the jacket before
32 filing for introduction in the Senate or introduction in the House of
33 Representatives.

34 (7) A joint resolution authorizing the introduction of a bill pursuant to
35 subdivision (6) of this section.

36 (8) Any bills primarily affecting any State or local pension or retirement
37 system, provided that the bill has been submitted to the Bill Drafting
38 Division of the Legislative Services Office no later than 4:00 P.M.
39 Wednesday, May 21, 2008, and is introduced in the House of
40 Representatives or filed for introduction in the Senate no later than
41 4:00 P.M. Wednesday, May 28, 2008.

42 (9) Joint resolutions, House resolutions, and Senate resolutions authorized
43 for introduction under Senate Rule 40(b) or House Rule 31.

44 (10) A joint resolution adjourning the 2007 Regular Session, sine die.

1 (11) Bills to disapprove rules under G.S. 150B-21.3.

2 **SECTION 3.** A bill containing no substantive provisions may not be
3 introduced in the House of Representatives during the 2008 Regular Session.

4 **SECTION 4.** The Speaker of the House of Representatives or the President
5 Pro Tempore of the Senate may authorize appropriate committees or subcommittees of
6 their respective houses to meet during the interims between sessions to:

7 (1) Review matters related to the State budget for the 2007-2009
8 biennium,

9 (2) Prepare reports, including revised budgets, or

10 (3) Consider any other matters as the Speaker of the House of
11 Representatives or the President Pro Tempore of the Senate deems
12 appropriate,

13 except that no committee or subcommittee of a house may consider, after the date of
14 adjournment provided in Section 1 of this resolution and before the date of reconvening
15 provided in Section 2 of this resolution, any bill, or proposed committee substitute for
16 such bill, which originated in the other house. A conference committee may meet in the
17 interim upon approval by the Speaker of the House of Representatives or the President
18 Pro Tempore of the Senate.

19 **SECTION 5.** This resolution is effective upon ratification.
