AN ACT TO APPROPRIATE FUNDS FOR TWO ADDITIONAL ASSISTANT

DISTRICT ATTORNEYS AND TWO ADDITIONAL VICTIM WITNESS LEGAL

ASSISTANTS FOR THE 13TH PROSECUTORIAL DISTRICT.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of two hundred ninety-nine thousand four hundred sixty-two dollars (\$299,462) for the 2007-2008 fiscal year and the sum of two hundred eighty-seven thousand nine hundred ten dollars (\$287,910) for the 2008-2009 fiscal year to establish the two additional assistant district attorneys authorized by this act and to establish two victim witness legal assistants for the 13th Prosecutorial District.
