2 AN ACT TO APPROPRIATE FUNDS FOR TWO ADDITIONAL ASSISTANT  
3 DISTRICT ATTORNEYS AND TWO ADDITIONAL VICTIM WITNESS LEGAL  
4 ASSISTANTS FOR THE 13<sup>TH</sup> PROSECUTORIAL DISTRICT.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 7A-60(a1) reads as rewritten:

7 "(a1) The counties of the State are organized into prosecutorial districts, and each  
8 district has the counties and the number of full-time assistant district attorneys set forth

39           **SECTION 2.** There is appropriated from the General Fund to the Judicial  
40 Department the sum of two hundred ninety-nine thousand four hundred sixty-two  
41 dollars (\$299,462) for the 2007-2008 fiscal year and the sum of two hundred  
42 eighty-seven thousand nine hundred ten dollars (\$287,910) for the 2008-2009 fiscal year  
43 to establish the two additional assistant district attorneys authorized by this act and to  
44 establish two victim witness legal assistants for the 13<sup>th</sup> Prosecutorial District.

**SECTION 3.** This act becomes effective July 1, 2007.
