2 AN ACT TO CHANGE THE NAME OF THE HIGHWAY FUND TO THE  
3 HIGHWAY MAINTENANCE FUND AND THE HIGHWAY TRUST FUND TO  
4 THE HIGHWAY SPECIAL PROJECT FUND AND TO ELIMINATE THE SIX  
5 AND ONE-HALF PERCENT DISTRIBUTION TO URBAN AREAS UNDER  
6 THE PROVISIONS OF THE POWELL BILL.

7 The General Assembly of North Carolina enacts:

8 **SECTION 1.** The Reviser of Statutes shall rename the Highway Fund to the  
9 Highway Maintenance Fund in the following statutes:

16 **SECTION 2.** The Reviser of Statutes shall rename the Highway Trust Fund  
17 to the Highway Special Project Fund in the following statutes:

24 **SECTION 3.** G.S. 136-41.1, 136-41.2, 136-41.2A, 136-41.3, and 136-41.4  
25 are repealed.

26 **SECTION 4.** This act becomes effective July 1, 2008.
