5	The General Assembly of North Carolina enacts:
6	SECTION 1. G.S. 166A-3 reads as rewritten:
7	"§ 166A-3. Limitations.
8	Nothing in this Article shall be construed to:
9	(1) Interfere with dissemination of news or comment on public affairs; but
10	any communications facility or organization, including but not limited
11	to radio and television stations, wire services, and newspapers, may be
12	requested to transmit or print public service messages furnishing
13	information or instructions in connection with an emergency, disaster
14	or war; or<u>war.</u>
15	(2) Limit, modify modify, or abridge abridge, except as provided in
16	subdivision (3) of this section, the authority of the Governor to
17	proclaim martial law or exercise any other powers vested in him under
18	the Constitution, statutes, or common law of this State independent of,
19	or in conjunction with, any provisions of this Article.
20	(3) <u>Authorize the taking, confiscation, or seizure, of lawfully possessed</u>
21	firearms, ammunition, or ammunition components."
22	SECTION 2. Article 36A of Chapter 14 of the General Statutes is amended
23	by adding a new section to read:
24	"§ 14-288.1A. Limitation.
25	Nothing in this Article shall be construed to authorize the taking, confiscation, or
26	seizure of lawfully possessed firearms, ammunition, or ammunition components."
27	SECTION 3. G.S. 14-288.7 reads as rewritten:

1	"§ 14-288.7. Transporting dangerous weapon or substance during emergency;
2	possessing off premises; exceptions.
3	(a) Except as otherwise provided in this section, it is unlawful for any person to
4	transport or possess off his own premises any dangerous weapon or substance in any
5	area:
6 7	(1) In which a declared state of emergency exists; exists, unless the dangerous weapon transported or possessed is a firearm, ammunition,
8	or an ammunition component; or
9	(2) Within the immediate vicinity of which a riot is occurring.
10	(b) This section does not apply to persons exempted from the provisions of
11	G.S. 14-269 with respect to any activities lawfully engaged in while carrying out their
12	duties.
13	(c) Any person who violates any provision of this section is guilty of a Class 1
14	misdemeanor."
15	SECTION 4. G.S. 14-288.12(b) reads as rewritten:
16	"(b) The ordinances authorized by this section may permit prohibitions and
17	restrictions:
18	(1) Of movements of people in public places;
19	(2) Of the operation of offices, business establishments, and other places
20	to or from which people may travel or at which they may congregate;
21	(3) Upon the possession, transportation, sale, purchase, and consumption
22	of alcoholic beverages;
23	(4) Upon-Subject to G.S. 14-288.1A, upon the possession, transportation,
24	sale, purchase, storage, and use of dangerous weapons and substances,
25	and gasoline; and
26	(5) Upon other activities or conditions the control of which may be
27	reasonably necessary to maintain order and protect lives or property
28	during the state of emergency.
29	The ordinances may delegate to the mayor of the municipality the authority to
30	determine and proclaim the existence of a state of emergency, and to impose those
31	authorized prohibitions and restrictions appropriate at a particular time."
32	SECTION 5. This act becomes effective December 1, 2007.
