1	SECTION 3. The precincts, tracts, block groups, and blocks in Section 2 of
2	this act shall be as shown on the General Assembly's redistricting database as of January
3	1, 2007.
4	SECTION 4. In the election of 2008, the commissioners representing
5	Districts 1, 3, 5, and 7 shall be elected to two-year terms, and the commissioners
6	representing Districts 2, 4, and 6 shall be elected to four-year terms. All subsequent
7	terms shall be four years.
8	SECTION 5. This act is effective when it becomes law.
