## A BILL TO BE ENTITLED

AN ACT REMOVING CERTAIN DESCRIBED PROPERTY FROM THE CORPORATE LIMITS OF THE CITY OF GREENSBORO.
The General Assembly of North Carolina enacts:
SECTION 1. The following described property is removed from the corporate limits of the City of Greensboro:
