39 **SECTION 2.** There is appropriated from the General Fund to the Judicial 40 Department the sum of one million four hundred eighty-three thousand thirty-five 41 dollars (\$1,483,035) for the 2007-2008 fiscal year and the sum of one million four 42 hundred thirty-three thousand nine hundred seventy dollars (\$1,433,970) for the 43 2008-2009 fiscal year to establish the 15 additional assistant district attorneys 44 authorized by this act. 1

SECTION 3. This act becomes effective July 1, 2007.
