If the recipient's physician or health plan 8 determines that operating under the standard 90-day time frame could 9 seriously jeopardize the enrollee's life or health or ability to attain, maintain, 10 or regain maximum function, then each level of review must be completed 11 within 72 hours, except that this expedited time frame may be extended by 12 up to 14 calendar days if the recipient requests an extension. 13 Coverage of services during review. – When the decision is a reduction, (4) 14 suspension, termination, or denied request for increase of existing services, 15 notwithstanding the request for review, the services shall be covered in accordance with the decision under review, and services which are 16 17 terminated or suspended services shall not be covered, unless and until the decision is overturned on review. 18 Review of decisions pursuant to Programmatic changes. - The Program review 19 (c) 20 process set forth in this section shall not apply to instances in which the sole basis for the decision is a provision in the State plan or in Federal or State law requiring an automatic 21 22 change in eligibility, enrollment, or a change in coverage under the health benefits package that 23 affects all applicants or enrollees or a group of applicants or enrollees without regard to their 24 individual circumstances. 25 Notice. – A recipient shall receive timely written notice of any decision subject to (d) 26 27 28 29 30
  - review under this section in accordance with the requirements of 42 C.F.R. § 457.1180. The notice shall include the reasons for the decision, an explanation of applicable rights to review of that decision, the standard and expedited time frames for review, the manner in which a review can be requested, and the circumstances under which enrollment may continue pending review.
  - Rule-Making authority. The Department shall have the authority to adopt rules for the implementation and operation of the Program review process."

**SECTION 2.** G.S. 150B-1(e) is amended by adding a new subdivision to read:

- "(17) The Department of Health and Human Services with respect to the review of North Carolina Health Choice Program determinations regarding delay, denial, reduction, suspension, or termination of health services, in whole or in part, including a determination about the type or level of services."
- **SECTION 3.** This act becomes effective July 1, 2010, and applies to reviews of Health Choice Program enrollment, eligibility, or health services decisions requested by Health Choice Program applicants or recipients on or after that date.
