1 A JOINT RESOLUTION HONORING THE DUKE BLUE DEVILS FOR WINNING THE  
2 2010 NATIONAL LACROSSE CHAMPIONSHIP.

3 Whereas, on May 31, 2010, the Duke University men's lacrosse team defeated Notre  
4 Dame by a score of 6-5 in overtime to capture the 2010 National Collegiate Athletic  
5 Association (NCAA) Division I Championship; and

6 Whereas, this championship gave Duke University its first Division I NCAA title  
7 for the men's lacrosse program, providing the university with 12 NCAA titles in five sports; and

8 Whereas, during the semifinal game of the NCAA tournament on May 29, 2010, the  
9 No. 5 seeded Duke University upset the No. 1 seeded University of Virginia winning the game  
10 with a score of 14-13; and

11 Whereas, the lacrosse team finished its season with a record of 16-4 overall, which  
12 is the fourth time since 2005 that the program has won at least 16 games in a season; and

13 Whereas, the lacrosse program has an overall record of 455 wins, including 20  
14 NCAA tournament wins; and

15 Whereas, much of the Blue Devils' success can be attributed to the leadership of  
16 head coach, John Danowski, who during his four seasons at Duke University has earned 66  
17 career victories and 11 NCAA tournament wins; and

18 Whereas, many individual team members were recognized for their efforts during  
19 the year and throughout their college careers, including Ned Crotty, the recipient of the 2010  
20 Tewaaron Trophy, which recognizes the nation's top lacrosse player; and

21 Whereas, several players were selected to either All-Tournament teams, United  
22 States Intercollegiate Lacrosse Association All-America teams, or both, including CJ Costabile,  
23 Zach Howell, Michael Manley, Max Quinzani, Ned Crotty, and Parker McKee; and

24 Whereas, Duke University is leader among the nation's best academic institutions,  
25 and this year lacrosse members Parker McKee and Max Quinzani were named to the United  
26 States Intercollegiate Lacrosse Association Scholar All-America Squad; and

27 Whereas, these accomplishments reflect favorably on the lacrosse tradition that  
28 began in 1938 at Duke University; and

29 Whereas, the success of the men's lacrosse team is a fitting testimonial and  
30 memorial to the program's former players and coaches, including Tony Cullen, who, as a  
31 member of the team from 1978 to 1980, scored 106 goals and had 114 assists and, as the team's  
32 head coach from 1982 to 1990, led the team to an overall record of 71-54; and

33 Whereas, these extraordinary accomplishments bring great honor and distinction to  
34 the State of North Carolina and deserve recognition by the State; Now, therefore,

35 Be it resolved by the Senate, the House of Representatives concurring:



1           **SECTION 1.** The General Assembly expresses the appreciation and admiration of  
2 the people of North Carolina to the Duke University men's lacrosse team for winning the 2010  
3 National Collegiate Athletic Association Division I Championship.

15 Duke University lacrosse player and coach, for his contributions to the University's lacrosse  
16 program.

17           **SECTION 4.** The Secretary of State shall transmit a certified copy of this  
18 resolution to Duke University President Richard H. Brodhead, Vice President and Director of  
19 Athletics Kevin White, the family of Tony Cullen, and all of the individuals honored in this  
20 resolution.

21           **SECTION 5.** This resolution is effective upon ratification.
