## A BILL TO BE ENTITLED

2	AN ACT TO AUTHORIZE THE EASTERN BAND OF CHEROKEE INDIANS, A		
3	FEDERALLY RECOGNIZED INDIAN TRIBE AND SOVEREIGN NATION, TO		
4	ESTABLISH A TRIBAL ALCOHOLIC BEVERAGE CONTROL COMMISSION TO		
5	REGULATE THE PURCHASE, POSSESSION, CONSUMPTION, SALE, AND		
6	DELIVERY OF ALCOHOLIC BEVERAGES AT RETAIL AND TO RECEIVE		
7	SHIPMENTS OF SPIRITUOUS LIQUOR AND FORTIFIED WINES FROM THE		
8	NORTH CAROLINA ALCOHOLIC BEVERAGE CONTROL COMMISSION.		
9	The General Assembly of North Carolina enacts:		
10	<b>SECTION 1.</b> G.S. 18B-203(17) reads as rewritten:		
11	"(17) Provide for the distribution of spirituous liquor to armed forces installations		
12	within this State for resale on the installation; installation and to the Eastern		
13	Band of Cherokee Indians for resale on Indian Country lands within this		
14	State under the jurisdiction of the Eastern Band of Cherokee Indians."		
15	SECTION 2. Article 1 of Chapter 18B of the General Statutes is amended by		
16	6		
17	" <u>§ 18B-112. Tribal alcoholic beverage control.</u>		
18	(a) Authority of Tribal Commission. – In accordance with the provisions of 18 U.S.C. §		
19	1161, the Eastern Band of Cherokee Indians, a federally recognized Indian tribe and sovereign		
20	nation, is authorized to establish a tribal alcoholic beverage control commission to regulate the		
21	purchase, possession, consumption, sale, and delivery of alcoholic beverages on any land		
22	designated as Indian Country pursuant to 18 U.S.C. § 1151. The provisions of this section shall		
23	apply only so long as the Eastern Band of Cherokee Indians tribe adopts, by ordinance and in		
24	its entirety, this Chapter as its ABC law and complies with the provisions thereof. The tribal		
25	commission shall have the same authority as the North Carolina Alcoholic Beverage Control		
26	Commission in the issuance of permits to retail establishments, located wholly on Indian		
27	Country lands under the jurisdiction of the Eastern Band of Cherokee Indians, and the		
28	regulation of the purchase, possession, consumption, sale, and delivery of alcoholic beverages		
29	at retail outlets and premises.		
30	(b) <u>Authority of the North Carolina Alcoholic Beverage Control Commission. – The</u>		
31	North Carolina Alcoholic Beverage Control Commission shall have the authority to enter into		
32	an agreement, but not sooner than July 1, 2013, with the tribal commission to provide for the		
33 34	sale, delivery, and distribution of spirituous liquor and fortified wines to the tribal commission.		
34 35	(c) <u>Failure to Comply With Laws of This State. – If the tribal commission fails to adopt</u> this Chapter by ordinance, fails to amend tribal ABC law to comply with amendments to this

Chapter within six months of passage of such amendments, or fails to comply with the 1 2 provisions of this Chapter as required by 18 U.S.C. § 1161, the North Carolina Alcoholic 3 Beverage Control Commission is authorized to terminate and prohibit future delivery of any 4 alcoholic beverages from any person to the tribal commission until the tribal commission complies with the provisions of this Chapter and 18 U.S.C. § 1161. 5 Conflict of Laws. – If any provision of this section or its application conflicts with 6 (d) 7 federal law, the conflict of laws shall be resolved in favor of the federal law unless compliance 8 with the federal law abrogates a right reserved to the State under the United States 9 Constitution."

**SECTION 3.** This act is effective when it becomes law.
