7	SECTION 1. The General Assembly supports the recommendations of the Stroke			
8	Advisory Council, as approved by the Justus-Warren Heart Disease and Stroke Prevention Task

18	<b>SECTION 2.</b> There is appropriated from the General Fund to the Department of			
19	Health and Human Services, Division of Public Health, the sum of four hundred thousand			
20	dollars (\$400,000) for the 2011-2012 fiscal year and the sum of four hundred thousand dollars			
21	(\$400,000) for the 2012-2013 fiscal year. These funds shall be allocated to the Heart Disease			
22	and Stroke Prevention Branch for continuation of community education campaigns and			
23	communication strategies in partnership with the American Heart Association/American Stroke			
24	Association on stroke signs and symptoms and the importance of immediate response.			
25	<b>SECTION 3.</b> There is appropriated from the General Fund to the Department of			
26	Health and Human Services, Division of Public Health, the sum of fifty thousand dollars			
27	(\$50,000) for the 2011-2012 fiscal year and the sum of fifty thousand dollars (\$50,000) for the			
28	2012-2013 fiscal year. These funds shall be allocated for continued operations of the Stroke Advisory Council.
