1	AUTHORIZATION TO ADDRESS MEDICAID LIABILITIES INCURRED IN THE
2	2009-2010 FISCAL YEAR
3	SECTION 3. Notwithstanding Chapter 143C of the General Statutes, of the funds
4	in the unreserved credit balance on June 30, 2010, up to the sum of one hundred twenty-five
5	million dollars (\$125,000,000) may be used to address Medicaid liabilities incurred in the
6	2009-2010 fiscal year, and funds are hereby appropriated for this purpose. The Director of the
7	Budget shall report on the implementation of this section to the chairs of the Senate and House
8	of Representatives Appropriations Committees and the Fiscal Research Division by October 1,
9	2011.
10	EFFECTIVE DATE
11	SECTION 4. This act is effective when it becomes law.
