

A BILL TO BE ENTITLED 1 2 AN ACT TO ESTABLISH THE JOINT LEGISLATIVE STUDY COMMITTEE ON 3 GRANDPARENTS' VISITATION RIGHTS AND CHILD CUSTODY. 4 The General Assembly of North Carolina enacts: 5 SECTION 1. There is created the Joint Legislative Study Committee on 6 Grandparents' Visitation Rights and Child Custody (Committee). The Committee shall consist 7 of 10 members to be appointed as follows: 8 (1)Five members of the Senate appointed by the President Pro Tempore of the 9 Senate. 10 (2) Five members of the House of Representatives appointed by the Speaker of 11 the House of Representatives. 12 The President Pro Tempore of the Senate shall designate one senator as cochair, and 13 the Speaker of the House of Representatives shall designate one representative as cochair. 14 Vacancies on the Committee shall be filled by the same appointing authority who made the 15 initial appointment. 16 The Committee, while in the discharge of its official duties, may exercise all powers 17 provided for under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4. The Committee may 18 meet at any time upon the joint call of the cochairs. The Committee may meet in the Legislative 19 Building or the Legislative Office Building. The Committee may contract for professional, 20 clerical, or consultant services as provided by G.S. 120-32.02. 21 The Legislative Services Commission, through the Legislative Services Officer, 22 shall assign professional staff to assist the Committee in its work. The Senate's and House of 23 Representatives' Directors of Legislative Assistants shall assign clerical staff to the Committee, 24 and the expenses relating to the clerical employees shall be borne by the Committee. Members 25 of the Committee shall receive subsistence and travel expenses at the rates set forth in 26 G.S. 120-3.1, 138-5, or 138-6, as appropriate. SECTION 2. The Committee shall study grandparents' visitation rights and the use 27 28 of health-related conditions as a factor in determining child custody. In conducting the study, 29 the Committee shall consider issues related to the following: 30 The State's current laws regarding custody and visitation. (1)The State's current laws regarding the factors a court may consider in 31 (2)determining custody, specifically as related to the health of the custodial 32 33 parent. 34 The State's current laws regarding grandparents' visitation rights. (3) Legislation adopted by other states addressing grandparents' visitation rights. 35 (4)

12	SECT	TON 3. The Committee shall make a final report of its findings and	
13	recommendations to the 2013 General Assembly, prior to its convening. The Committee shall		
14	terminate upon the filing of its final report.		
15	SECT	TON 4. This act is effective when it becomes law.
