1	A HOUSE RESOLUTION ESTABLISHING A HOUSE SELECT COMMITTEE TO STUDY			
2	THE ISSUE OF FEDERALISM AND ABUSES OF FEDERAL AUTHORITY,			
3	INCLUDING WHETHER NORTH CAROLINA SHOULD APPLY TO CONGRESS FOR			
4	A CONVENTION OF THE STATES UNDER ARTICLE V OF THE CONSTITUTION OF THE UNITED STATES.			
5 6	OF THE UNITED STATES. Whereas, the authors of the Constitution empowered state legislators to be guardian			
0 7	of liberty against abuses of power by the federal government; and			
8	Whereas, the federal government has created a crushing national debt through			
9	improper and imprudent spending; and			
10	Whereas, the federal government has invaded the legitimate roles of the states			
11	through the manipulative process of federal mandates, many of which are largely unfunded and			
12	unilaterally enacted by the executive branch; and			
13	Whereas, it is the solemn duty of elected officials, including those in state			
14	legislatures to protect the liberty of our people, particularly for the generations to come, and to			
15	propose amendments to the Constitution of the United States through a Convention of the			
16	States under Article V of the Constitution of the United States to place clear restraints on these			
17	and related abuses of power; and			
18	Whereas, other states have applied to Congress for a Convention of the States under			
19	Article V of the Constitution of the United States, and additional states have either introduced			
20	or passed similar resolutions in at least one legislative body; Now, therefore,			
21	Be it resolved by the House of Representatives:			
22	<b>SECTION 1.</b> In accordance with House Rule 26(a), there is established the House			
23	Select Committee on a Convention of the States.

20	Convention of the States limited to proposing amendments to the			
28	Constitution of the United States that impose fiscal restraints on the federal			
29	government, limit the power and jurisdiction of the federal government, and			
30	limit the terms of office for its officials and members of Congress.			
31	(2) Examining the economic impact on North Carolina citizens, communities,			
32	and businesses of federal executive branch action which suspends,			
33	disregards, or otherwise ignores other federal law.			
34	(3) Determining whether enforcement activity premised on federal legislative			
35	authority has been needlessly and unnecessarily expanded beyond the			
36	original intent of such legislation and whether North Carolina may enact			
37	laws that would lessen the burden of such enforcement efforts on its citizens.
