4 MAGISTRATES FOR CUMBERLAND COUNTY.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** G.S. 7A-133 reads as rewritten:

7 "**§ 7A-133. Numbers of judges by districts; numbers of magistrates and additional seats**  
8 **of court, by counties.**

9 (a) Each district court district shall have the numbers of judges as set forth in the  
10 following table:

15 (c) Each county shall have the numbers of magistrates and additional seats of district  
16 court, as set forth in the following table:

17 County	18 Magistrates 19 Min.	20 Additional 21 Seats of 22 Court

24 **SECTION 2.** There is appropriated from the General Fund to the Judicial  
25 Department the sum of three hundred eighteen thousand seven hundred eighty-eight dollars  
26 (\$318,788) for the 2013-2014 fiscal year and the sum of three hundred eighteen thousand seven  
27 hundred eighty-eight dollars (\$318,788) for the 2014-2015 fiscal year to establish two  
28 additional district court judge positions for District Court District 12.

29 **SECTION 3.** There is appropriated from the General Fund to the Judicial  
30 Department the sum of ninety thousand nine hundred thirty-nine dollars (\$90,939) for the  
31 2013-2014 fiscal year and the sum of ninety thousand nine hundred thirty-nine dollars  
32 (\$90,939) for the 2014-2015 fiscal year to establish two additional magistrate positions for  
33 Cumberland County.



1           **SECTION 4.** The Governor shall appoint the two additional district court judges  
2 for District Court District 12 authorized by this act, and those judges' successors shall be  
3 elected in the 2014 election for four-year terms commencing January 1, 2015.

4           **SECTION 5.** This act becomes effective July 1, 2013.
